Informal Note by the Co-Facilitators

Paragraph 111 of the Tunis Agenda for the Information Society requested the United Nations General Assembly to make an overall review of the implementation of WSIS outcomes in 2015, and by GA resolution 68/198 of 20 December 2013, it was decided that modalities for this should be finalized by end of March 2014.

As we noted in the first informals, the review should also be done in line with the GA resolutions and decisions on integrated and coordinated implementation of and follow-up to the outcomes of the major UN conferences and summits in the economic, social and related fields.

In statements and comments heard so far, some Member States have called for the review to adhere to that of the Tunis agenda, paragraph 111, i.e. the "review of the implementation of WSIS outcomes". Many have underlined the role that technology can play in assisting development efforts. Others have stressed the importance of addressing the digital divide and improving broadband access in developing countries. Some delegations have also indicated the need to take into account paragraphs 69 to 71 of the Tunis agenda concerning enhanced cooperation. One call was also made to see the review as a roadmap for future discussions in various forums to help determine how best to implement WSIS outcomes.

Some delegations have also underscored the need to avoid duplication and called for the use of existing mechanisms, including the Commission of Science and Technology for Development as the Focal Point for the review. And while there are some Member States who believe that the review should be carried out in the context of a summit, several others take the view that this may not be the most efficient mechanism. One delegation stated that this review could be a part of the September 2015 Summit.

Some delegations believe that there should be wide stakeholder participation in line with the WSIS practise, and other delegations also pointed out the unique role that the GA can play in ensuring a universal and transparent participation of all states and stakeholders.
