## **Report of the Open Working Group on Sustainable Development Goals established pursuant to General Assembly resolution 66/288**

*The General Assembly,*

*Recalling* the outcome document of the United Nations Conference on Sustainable Development, entitled “The future we want”, contained in resolution 66/288 of 11 September 2012, which, *inter alia*, resolved to establish an inclusive and transparent intergovernmental process on sustainable development goals open to all stakeholders, with a view to developing global sustainable development goals to be agreed by the General Assembly,

1. *Acknowledges* the conclusion of the work of the Open Working Group on Sustainable Development Goals, and *welcomes* its report issued as document A/68/970<sup>1</sup>,

2. *Decides* that the proposal of the Open Working Group on Sustainable Development Goals contained in the report shall be the basis for integrating sustainable development goals into the post-2015 development agenda, while recognizing fully that other inputs may also be considered in this intergovernmental negotiation process at the sixty-ninth session of the General Assembly.
