Government of the Kyrgyz Republic

On approval of the Action Plan of the Kyrgyz Republic on Implementation of Security Council resolution 1540 (2004)

In order to ensure implementation of Security Council resolutions 1540 (2004) and 1977 (2011), the Government of the Kyrgyz Republic decides that:

- 1. The Action Plan of the Kyrgyz Republic on Implementation of Security Council resolution 1540 (2004) (hereinafter referred to as the Action Plan) set out in the annex hereto shall be adopted;
- 2. The Ministry of Economic Affairs of the Kyrgyz Republic shall be responsible for coordination and monitoring of implementation of the Action Plan;

- 3. Ministries, government agencies and other state bodies shall:
 - Ensure implementation of the Action Plan;
 - Submit to the Ministry of Economic Affairs information on implementation of the Action Plan, on a quarterly basis, by the fifteenth day of the month following the reporting period.
- 4. The Ministry of Economic Affairs shall submit to the Office of the Government of the Kyrgyz Republic an overview of implementation of the Action Plan, on a quarterly basis, by the twenty-fifth day of the month following the reporting period.
- 5. The Ministry of Foreign Affairs of the Kyrgyz Republic shall report to the Security Council Committee established pursuant to resolution 1540 (2004) on the adoption of the Action Plan.

6. Monitoring of execution of this Decision shall be the responsibility of the department of economic affairs and investments; the department of international cooperation; the department of defence, law and order and emergency situations; the department of education; the department of culture and sport; and the department of the agro-industrial complex and the environment of the Office of the Government of the Kyrgyz

7. The present Decision shall enter into force on the day of its official publication.

Action Plan of the Kyrgyz Republic on Implementation of Security Council resolution 1540 (2004)

Security Council resolution 1540 (2004), adopted on 28 April 2004, is an international legal and political instrument of significance that has the potential to prevent the proliferation of weapons of mass destruction (hereinafter WMD).

The resolution's primary purpose is to establish effective national barriers that prevent non-State actors, especially terrorists, from acquiring WMD and their means of delivery.

The resolution provides for practical measures at the national level to be taken by all States Members of the United Nations to

strengthen their legislative framework and law enforcement practices. These measures provide, above all, for materials related to WMD and their means of delivery to be accounted for, secured and physically protected, their export and transfer across borders to be monitored, and illicit trafficking and brokering to be prevented and countered. The instrument aims to coordinate efforts at the regional and international levels to prevent illicit trafficking in WMD and their means of delivery.

Commitment to non-proliferation of WMD is a fundamental principle of the foreign and domestic policy of the Kyrgyz Republic.

The Kyrgyz Republic supports Security Council resolution 1540

(2004) and is taking consistent measures to implement it.

Kyrgyzstan, which does not possess nuclear, chemical or biological weapons or their means of delivery, is effecting measures to bolster the national export control regime, in accordance with the resolution, and to strengthen oversight and monitoring of the flow of materials and equipment used in the development and manufacture of

Kyrgyzstan has ratified the primary international agreements on the non-proliferation of WMD: the 1993 Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction (the Chemical Weapons Convention); the Convention on the Prohibition of the Development, Production and Stockpiling of Bacteriological

(Biological) and Toxin Weapons and on Their Destruction (the

Biological Weapons Convention); the Treaty on the Non-

Proliferation of Nuclear Weapons (NPT); the Agreement with the

International Atomic Energy Agency for the Application of

Safeguards in Connection with the Treaty on the Non-Proliferation of

Nuclear Weapons and the Additional Protocol thereto; the Treaty on

a Nuclear-Weapon-Free Zone in Central Asia; and the Joint

Convention on the Safety of Spent Fuel Management and on the

Safety of Radioactive Waste Management. Work to implement these

international treaties and agreements is ongoing.

The Export Control Act of the Kyrgyz Republic was signed

into law in January 2003. It establishes the principles for

implementing state policy and the legal bases for export control activity carried out by state agencies of the Kyrgyz Republic and individuals and entities engaged in international trade.

A number of secondary laws have been adopted to implement this Act. They set forth procedures for implementation in Kyrgyzstan of export control for controlled goods. Practical border control measures to monitor the transfer of radioactive materials are being taken jointly with donor countries.

At the same time, in order to establish an export control regime in Kyrgyzstan that is in compliance with international regulations; that provides for effective oversight of the handling of goods and technologies related to WMD and their means of delivery; and that

effectively bars non-State actors from gaining access to such weapons and related materials, work on legislation and practical actions requiring productive cooperation on the part of various State authorities must continue and intensify.

This Action Plan of the Kyrgyz Republic on Implementation of Security Council resolution 1540 (2004) was developed to achieve effective cooperation of all state agencies engaged in the implementation of resolution 1540 (2004) and to ensure full implementation of the resolution and increased national capacity to foster non-proliferation and prevent various threats. The Action Plan was developed based on the idea that countries with the appropriate

capacities may, under resolution 1540 (2004), provide assistance to

other States that need help in implementing the resolution.
