**United Nations Convention on the Law of the Sea
Montego Bay, 10 December 1982**

Receipt of the partial Submission made by the Republic of Chile
to the Commission on the Limits of the Continental Shelf
in respect of the Juan Fernández Archipelago region

The Secretary-General of the United Nations communicates the following:

On 18 November 2025, the Republic of Chile submitted to the Commission on the Limits of the Continental Shelf, in accordance with article 76, paragraph 8, of the United Nations Convention on the Law of the Sea, information on the limits of the continental shelf beyond 200 nautical miles from the baselines from which the breadth of the territorial sea is measured in respect of the Juan Fernández Archipelago region.

It is noted that the Convention entered into force for Chile on 24 September 1997.

According to the coastal State, this is a partial Submission, which follows the preliminary information submitted on 8 May 2009 pursuant to the *Decision regarding the workload of the Commission on the Limits of the Continental Shelf and the ability of States, particularly developing States, to fulfil the requirements of article 4 of annex II to the United Nations Convention on the Law of the Sea, as well as the decision contained in SPLOS/72, paragraph (a)* (SPLOS/183).

In accordance with the rules of procedure of the Commission (CLCS/40/Rev.2), the present communication is being circulated to all Member States of the United Nations, as well as States Parties to the Convention, in order to make public the executive summary of the Submission, including all illustrative maps and lists of geographical coordinates of points contained therein. The executive summary is available on the website of the Division for Ocean Affairs and the Law of the Sea, Office of Legal Affairs, at: www.un.org/Depts/los.

The consideration of the Submission will be included in the provisional agenda of the sixty-seventh session of the Commission.

Upon completion of the consideration of the submission, the Commission will issue recommendations pursuant to article 76 of the Convention.
