



## 1. INTRODUCTION

---

- 1-1 This revised Executive Summary document has been prepared as part of the Submission by the Republic of Mauritius to the Commission on the Limits of the Continental Shelf ('the Commission') pursuant to paragraph 8 of Article 76 of the 1982 United Nations Convention on the Law of the Sea ('the Convention') in support of the establishment by the Republic of Mauritius of the outer limits of the continental shelf that lie beyond 200 nautical miles (M) from the baselines from which the breadth of the territorial sea of the Republic of Mauritius is measured (hereinafter referred to as 'the territorial sea baselines') in the region of Rodrigues Island.
- 1-2 The Republic of Mauritius consists of a group of islands in the Indian Ocean. The main Island of Mauritius is located at longitude 57°30' east, and latitude 20°00' south, approximately 900km east of Madagascar and is part of the Mascarene Islands. The total land area of the Republic of Mauritius is approximately 1,950km<sup>2</sup>. Under the *Constitution of Mauritius* the territory of Mauritius includes:
- the main island of Mauritius;
  - the islands of *Cargados Carajos* (St Brandon Group) located some 402km north of the main island;
  - the *Agalega Islands* located 933km north of the main island;
  - *Tromelin* located 580km north-west of the main island;
  - the *Chagos Archipelago* that lies approximately 2200km north-east of the main island; and,



- Rodrigues Island located approximately 560km east of the main island of Mauritius.

- 1-3** The Republic of Mauritius is party to the Convention, which it signed on the day it was opened for signature on 10 December 1982, and subsequently ratified on 4 November 1994. The *Maritime Zones Act 2005*, which repealed the *Maritime Zones Act 1977*, provides that the provisions of the Convention have the force of law in the Republic of Mauritius, and establishes maritime zones in accordance with the provisions of the Convention, including provisions defining the outer limits of the continental shelf.
- 1-4** Under Article 4 of Annex II to the Convention, as supplemented by the decisions of the Eleventh (SPLOS/72) and Eighteenth (SPLOS/183) meetings of the States Parties to the Convention respectively regarding the ten-year period established by Article 4 of Annex II to the Convention, a coastal State for which the Convention entered into force before 13 May 1999 is required to submit particulars of the outer limits of the continental shelf, along with supporting scientific and technical data, to the Commission by 13 May 2009. This Submission by the Republic of Mauritius satisfies that requirement.
- 1-5** The Republic of Mauritius has, for the purposes of preparing this Submission, applied the relevant provisions of Article 76 of the Convention, together with the relevant provisions of the *Rules of Procedure of the Commission on the Limits of the Continental Shelf* (CLCS/40/Rev.1) adopted by the Commission on 17 April 2008 (hereinafter referred to as the 'Rules of Procedure') and, the recommendations contained in the *Scientific and Technical Guidelines of the Commission on the Limits of the Continental Shelf* (CLCS/11) adopted by the Commission on 13 May 1999 (hereinafter referred to as 'the Guidelines').

- 1-6 This Submission is a partial submission concerning only the extended continental shelf in the region of Rodrigues Island.
- 1-7 The Republic of Mauritius made a partial submission (jointly with the Republic of Seychelles) on 1 December 2008 in respect of an area of extended continental shelf in the region of the Mascarene Plateau (**SMS-ES-DOC**). On 30 March 2011, the Commission adopted the “Recommendations of the Commission on the Limits of the Continental Shelf in regard to the Joint Submission” which conferred a joint jurisdiction to the two coastal States. The Republic of Mauritius has also submitted, in accordance with SPLOS/183, Preliminary Information in respect of another area of its extended continental shelf in the region of the Chagos Archipelago.
- 1-8 In accordance with Annex III to the Rules of Procedure and paragraphs 9.1.3 to 9.1.6 of the Guidelines, the original Submission made by the Republic of Mauritius on 6 May 2009 consists of three separate parts and comprising of an Executive Summary, a core analytical and descriptive part ('the Main Body'); and, a part containing all required supporting scientific and technical data arranged in a series of annexes ('supporting scientific and technical data').
- 1-9 The Commission established a Sub-Commission to examine the Submission in March 2014. In the course of the examination, Mauritius provided additional data and information to the Sub-Commission in July 2015 revising the outer limit of the Extended Continental Shelf in the region of Rodrigues Island. This Executive Summary (**MRS\_ES\_DOC\_Rev**) has been prepared by the Republic of Mauritius in order to present the modified outer limits of the continental shelf beyond 200 M contained in the Submission.

- 1-10** All areas of the continental shelf lying more than 200M from the territorial sea baselines of the territory of the Republic of Mauritius in the region of Rodrigues Island are referred to in this Submission as the 'extended continental shelf'.
- 1-11** The Republic of Mauritius wishes to highlight that this Submission has been prepared notwithstanding significant challenges posed by geographical isolation, and technical and financial constraints. In this regard, the Republic of Mauritius has received legal and technical assistance from the Commonwealth Secretariat during the preparation of this Submission.



## **2. OUTER LIMITS OF THE CONTINENTAL SHELF CONCERNING THE REGION OF RODRIGUES ISLAND**

---

- 2-1** As provided for under paragraph 1 of Article 76 of the Convention, the Republic of Mauritius has a continental shelf comprising the seabed and subsoil of the submarine areas that extend beyond its territorial sea throughout the natural prolongation of its land territory to the outer edge of the continental margin, up to the limits provided for in paragraphs 4 to 6 of Article 76 of the Convention or, to a distance of 200 M from the territorial sea baselines where the outer edge of the continental margin does not extend up to that distance.
- 2-2** Paragraphs 4 to 6 of Article 76 of the Convention set out the manner in which a coastal State may establish the outer edge of its continental margin and its extended continental shelf, wherever that margin extends beyond 200 M measured from the territorial sea baselines.
- 2-3** As set out in paragraph 7 of Article 76 of the Convention, a coastal State is to delineate the outer limits of the extended continental shelf by straight lines not exceeding 60 M in length, connecting fixed points defined by coordinates of latitude and longitude.
- 2-4** The information presented in support of this revised Submission establishes that the outer edge of the continental margin in the relevant land territory of the Republic of Mauritius in the region of Rodrigues Island extends beyond 200 M measured from the territorial sea baselines.
- 2-5** Section 7 of this revised Executive Summary provides an overview of the extended continental shelf in the region of Rodrigues Island determined by




the Republic of Mauritius, together with information concerning the Article 76 fixed points used to construct the outer limit line in this region.

### 3. MAPS AND COORDINATES

---

- 3-1 Two maps are included in this revised Executive Summary as **Figure 1 (MRS-ES-MAP-1\_R)** and **Figure 2 (MRS-ES-MAP-2\_R)** respectively, and as separate A0-size maps. **Figure 1** provides an overview of the area of extended continental shelf in the region of Rodrigues Island. **Figure 2** provides an overview of the area of extended continental shelf, together with the location of the Article 76 fixed points that define the outer limits of the extended continental shelf.
- 3-2 Lists of coordinates of the Article 76 fixed points that define the outer limits of the extended continental shelf submitted by the Republic of Mauritius are supplied in two annexes. **Annex 1 (MRS-ES-ANNEX 1\_R)** lists the fixed points defining the outer limits of the extended continental shelf in decimal degrees. **Annex 2 (MRS-ES-ANNEX 2\_R)** lists the same points in degrees, minutes and seconds. The provisions of Article 76 invoked to define each fixed point, as well as the distance between adjacent points, are indicated in both annexes. Wherever there is discrepancy between the two formats of the coordinates for a particular Article 76 fixed point, the Republic of Mauritius will apply the coordinates farthest seaward from its territorial sea baselines, whilst complying with the requirements of the relevant provisions of Article 76 of the Convention.

#### **4. PROVISIONS OF ARTICLE 76 INVOKED**

---

The Republic of Mauritius invokes paragraphs 4 (a)(ii), 4 (b), 5, 6 and 7 of Article 76 of the Convention in support of this Submission concerning the extended continental shelf in the region of Rodrigues Island.

#### **5. OUTSTANDING MARITIME DELIMITATIONS**

---

The Republic of Mauritius wishes to inform the Commission that the area of extended continental shelf in this Submission is not the subject of any dispute between it and any other State(s) pursuant to paragraph 2(a) of Annex I to the Rules of Procedure.

#### **6. COMMISSION MEMBERS AND EXPERTS WHO PROVIDED ADVICE ON THE SUBMISSION**

---

The Republic of Mauritius was assisted in the preparation of the Submission by one former member of the Commission on the Limits of the Continental Shelf namely Mr Harald Brekke (1997 – 2012). Professor J. Faleide and Dr Alexander Minakov of the University of Norway have also assisted Mauritius.



## 7. OVERVIEW OF THE EXTENDED CONTINENTAL SHELF IN THE REGION OF RODRIGUES ISLAND

---

- 7-1 Rodrigues Island is a volcanic island located approximately 560km east of the main island of Mauritius in the middle of the Indian Ocean. As at 2007, the human population of Rodrigues Island was estimated to be 37,500 with an average annual rate of population increase in order of 0.4 %. It has a size of around 105km<sup>2</sup> and is surrounded by a vast lagoon with fringing coral reefs. The island has an elongated shape and it is approximately 18km by 6.5km, rising to a maximum elevation of approximately 400m. The island is aged between 1.3 and 1.5 million years and was formed primarily from basaltic lava flows. The island surmounts the Rodriguez Ridge, the eastern part of which is embedded in a Depth Anomaly which is referred to as the Rodrigues Depth Anomaly.
- 7-2 The Rodriguez Ridge is a linear volcanic sea floor high, approximately 450km long, which extends continuously in an east-west trend at 19°S from the region of the Mascarene Plateau to the Central Indian Ridge ('CIR') in the east. Two smaller bathymetric features, the Three Magi and Gasitao Ridges (discovered in 1998) extend the Rodriguez Ridge further east up to the CIR. The eastern part of the Ridge, including Rodrigues Island, is embedded in the crust of the Rodrigues Depth Anomaly, a relatively smooth elevation that rises 800 – 1000m above the general abyssal depths of 4000m and does not show any segmentation. The Rodrigues Depth Anomaly is delineated by the Marie Celeste Fracture Zone to the north, the Flinders Fracture Zone to the south-east, a general slope between the Rodrigues Depth Anomaly and the abyssal depths to the south-west and continues further east of the CIR.
- 7-3 The Republic of Mauritius holds the view that the Rodrigues Depth Anomaly in which the Rodriguez Ridge and smaller ridges are embedded, is properly

classified as a submarine ridge and represents the submerged prolongation of its land territory of Rodrigues Island from where the continental shelf extends.


- 7-4 The outer limits of the extended continental shelf in the region of Rodrigues Island enclose an area of approximately **182,000** square kilometres extending beyond 200 M from the territorial sea baselines of the Republic of Mauritius and are defined by an outer limit line composed of **414** fixed points, of which:
- **143** points are defined by arcs 60 M from the foot of the slope (Article 76, paragraph 4(a)(ii) of the Convention);
  - **269** are defined by the constraint line 350 M from the territorial sea baseline of the Republic of Mauritius (Article 76, paragraph 5 of the Convention);
  - **2** points (ECS 1 and ECS 414), where the outer limit line of the extended continental shelf commences and terminates respectively at points located along the 200 M from the territorial sea baselines of the Republic of Mauritius in the region of Rodrigues Island.
- 7-5 Each successive pair of fixed points defining the outer limits of the extended continental shelf is connected by geodesics not exceeding 60 M in length, drawn in accordance with paragraph 7 of Article 76 of the Convention.
- 7-6 The list of Article 76 fixed points delineating the outer limits of the extended continental shelf in the region of Rodrigues Island is supplied in annexes **MRS-ES-ANNEX 1\_R** and **MRS-ES-ANNEX 2\_R** to this revised Executive Summary document.



## 8. NOTE OF AUTHENTICATION
