United Nations Convention on the Law of the Sea Montego Bay, 10 December 1982

Convening of the thirty-fifth Meeting of States Parties

The Secretary-General of the United Nations communicates the following pursuant to rule 5 (Notification) of the Rules of Procedure for Meetings of States Parties (SPLOS/2/Rev.5):

The thirty-fifth Meeting of States Parties to the United Nations Convention on the Law of the Sea will be held in New York, from 23 to 27 June 2025, ¹ in conformity with paragraph 53 of General Assembly resolution 79/144 of 12 December 2024. The provisional agenda of the Meeting will be available soon in document SPLOS/35/L.1 through the Official Document System of the United Nations (https://documents.un.org).

States Parties

The attention of the States Parties to the Convention is drawn to rule 13 of the Rules of Procedure (Submission of credentials). In this regard, the Secretary-General wishes to recall that original credentials of representatives duly signed by the Head of State or Government or the Minister for Foreign Affairs or any person authorized by either of them should be transmitted to the Secretariat (Division for Ocean Affairs and the Law of the Sea, Office of Legal Affairs, room DC2 0450, United Nations, New York, NY 10017). Credentials should explicitly indicate that they are issued for the "thirty-fifth Meeting of States Parties to the United Nations Convention on the Law of the Sea (23-27 June 2025)".

A scanned copy of the credentials, as well as other communications containing the names of representatives to the Meeting (such as letters and notes verbales from the permanent mission), should be submitted through the online e-Credentials module, which can be accessed through the e-deleGATE portal (edelegate.un.int).

¹ With reference to the letter dated 7 February 2025 from the Secretary-General addressed to all Member States of the United Nations and the letter dated 21 February 2025 from the Chef de Cabinet addressed to the President of the General Assembly regarding restrictive measures to be taken in the context of the ongoing liquidity crisis, it is recalled that all meeting bodies with a session of ten meetings or more are to reduce their number of meetings by at least 10 per cent and adjust their programmes of work accordingly. Consequently, conference services for the afternoon meeting on Friday, 27 June 2025, have been relinquished, and **the meeting will end by 1 p.m. on 27 June 2025**.

With reference to agenda item 10 (c) of the provisional agenda entitled "Commission on the Limits of the Continental Shelf: Election of members of the Commission", it would be appreciated if the credentials of States Parties were transmitted to the Secretariat as soon as possible and no later than twenty-four hours after the opening of the Meeting on 23 June 2025, for the timely conduct of the election. It is recalled that the Meeting of States Parties will consider the report of the Credentials Committee before the election. Accordingly, ballot papers will be distributed only to those States Parties whose credentials have been approved by the Meeting.

Attention is drawn to the understanding reached by the twenty-third Meeting of States Parties (see SPLOS/263, paragraph 101), according to which, in keeping with rule 1 of the Rules of Procedure, Meetings of States Parties can be adjourned and resumed as required and would terminate when the next Meeting of States Parties is convened. Therefore, the credentials of representatives for the thirty-fifth Meeting would cover the period from 23 June 2025 until the convening of the thirty-sixth Meeting of States Parties.

Observers

Pursuant to rule 17 of the Rules of Procedure (Accreditation of observers), observers referred to in rule 18 of the Rules of Procedure (Observers) and in the decision adopted by the twenty-ninth Meeting of States Parties (SPLOS/29/9 para. 120) are invited to transmit to the Secretariat (email: doalos@un.org, with original hard copy to follow by mail) the names of the representatives who will form part of their delegation, as soon as possible and preferably no later than 26 June 2025.
