United Nations Convention on the Law of the Sea Montego Bay, 10 December 1982

Convening of the thirty-second Meeting of States Parties

The Secretary-General of the United Nations communicates the following, pursuant to rule 5 (Notification) of the Rules of Procedure for Meetings of States Parties (SPLOS/2/Rev.5):

The thirty-second Meeting of States Parties to the United Nations Convention on the Law of the Sea will be held in New York from 13 to 17 June 2022, in conformity with paragraph 58 of General Assembly resolution 76/72 of 9 December 2021. The provisional agenda of the Meeting is contained in document SPLOS/32/L.1 available through the Official Document System of the United Nations (documents.un.org).

Parties

The attention of the States Parties to the Convention is drawn to rule 13 of the Rules of Procedure (Submission of credentials). In this regard, the Secretary-General wishes to remind that original credentials of representatives should be transmitted to the Secretariat (Division for Ocean Affairs and the Law of the Sea, Office of Legal Affairs, room DC2 0450, United Nations, New York, NY 10017), duly signed by the Head of State or Government or the Minister for Foreign Affairs or any person authorized by either of them. A scanned copy of the credentials, as well as other communications containing the names of representatives to the Meeting (such as letters and notes verbales from the permanent missions), should be submitted through the online e-Credentials module, which can be accessed through the e-deleGATE portal starting mid-April 2022 (edelegate un.int). For the timely conduct of the election of 21 members of the Commission on the Limits of the Continental Shelf, it would be appreciated if the credentials of States Parties were transmitted to the Secretariat as soon as possible and no later than twenty-four hours after the opening of the Meeting on 13 June 2022. It is recalled that the Meeting of States Parties will consider the report of the Credentials Committee before the election. Accordingly, ballot papers will be distributed only to States Parties with credentials that have been approved by the Meeting.

Attention is drawn to the understanding reached by the twenty-third Meeting of States Parties (see SPLOS/263, paragraph 101), according to which, in keeping with rule 1 of the Rules of Procedure, Meetings of States Parties can be adjourned and resumed as required and would terminate when the next Meeting of States Parties is convened. Therefore, it is suggested that the credentials of representatives for the

thirty-second Meeting would cover the period from 13 June 2022 until the convening of the thirty-third Meeting of States Parties.

Observers

Pursuant to rule 17 of the Rules of Procedure (Accreditation of observers), observers referred to in rule 18 of the Rules of Procedure (Observers) are invited to transmit to the Secretariat (email: doalos@un.org, with original hard copy to follow by mail) the names of the representatives who will form part of their delegation, as soon as possible and preferably no later than 16 June 2022.
