Goal

The goal of the first biennial Development Cooperation Forum (30 June-1 July) is to position the United Nations Economic and Social Council as a principal forum for global dialogue and policy review on the effectiveness and coherence of international development cooperation.

Objectives

By focusing on the mandates of GA resolutions 60/1 and 61/16, the Forum will aim to:

- 1. Serve as strategic input into intergovernmental deliberations taking place at the Monterrey Follow Conference in Doha and the Accra High-level Forum on Aid Effectiveness
- 2. Establish ownership of both developing and developed countries by addressing shared concerns

Actions

A number of specific actions will determine the success of the 2008 DCF, in particular the:

- 1. Selection of topics and country case studies for discussion
- 2. Selection of keynote speakers, panelists, moderators and rapporteurs
- 3. Development of effective guidelines for panelists and moderators
- 4. Choice of meeting format conducive to interactive discussion among panelists and participants
- 5. Provision of travel support to a significant number of high-level participants from low-income countries (by UNDESA)

Key deliverables

The thorough execution of these actions is expected to generate the following key deliverables:

- 1. Attendance by 80-100 ministers or Director-Generals responsible for development cooperation in developing and developed countries
- 2. Strong participation by other major stakeholder groups such as multilateral organizations, civil society, parliamentarians and the private sector
- 3. Combined attendance of 350-450 participants
- 4. Significant media interest in the Forum

Indicators of success

The 2008 DCF will be considered a success if the objectives are met. The following indicators will be used to assess the extent to which this is achieved:

- 1. Clear reflection of issues discussed at the DCF in upcoming intergovernmental processes
- 2. Positive feedback from stakeholders on the quality of debate
- 3. Ensuing resource mobilization
