Report of the Secretary-General

- 1. A statement is presented herewith which shows the payments received from Member States during the period 1 January to 19 September 1972, in respect of contributions to the United Nations regular budget. No payments in respect of the Special Account of the United Nations Emergency Force and the Ad Hoc Account for the United Nations Operation in the Congo were received during that period.
