Report of the Secretary-General

1. A statement is presented herewith which shows the payments received from Member States during the period 1 January to 17 September 1974 in respect of contributions to the United Nations regular budget and to the United Nations Emergency Force (1973) for the two six-month periods ended 24 April 1974 and ending 24 October 1974. No payments in respect of the Special Account of the United Nations Emergency Force (1956-1967) and the Ad Hoc Account for the United Nations Operation in the Congo were received during that period.
2. The payments received as shown in the annexed statement have been recorded by the United Nations in accordance with the relevant General Assembly resolutions and the Financial Regulations of the United Nations.

a/ In accordance with their announced policies, the Governments of the Byelorussian Soviet Socialist Republic, the German Democratic Republic, the Ukrainian Soviet Socialist Republic and the Union of Soviet Socialist Republics state that they have additionally deposited in national currencies in bank accounts in their respective countries, during the period 1 January to 17 September 1974, the equivalent of \$44,004, \$130,223, \$164,575 and \$1,247,961, respectively. They further state that these amounts are available to the United Nations in respect of their assessed share of the appropriations for technical assistance for the United Nations regular budget.
