Excellencies,

The President of the General Assembly has asked me to assume the role of facilitator to lead the consultations on the review the implementation of Resolution 61/16 of the General Assembly, on the strengthening of the Economic and Social Council.

I have accepted this designation and committed the efforts of the Permanent Mission of Chile to the United Nations to carry out the mandate entrusted in me.

In this regard, I would like to convene the first round of informal consultations of the General Assembly on Monday 7 March 2011, at 10am, in Conference Room 1; the second round will take place on Tuesday 15 March at 10am, in Conference Room 3.

Moreover, I have deemed it important to organize a public meeting with representatives of civil society, the private sector, and academia on this matter. I will inform your Excellencies in due time on the details of this event.

Regarding the informal consultations of 7 and 15 March, to be held within the framework of the General Assembly, I consider it useful to divide them into areas of work, taking into account the main issues contained in Res. 61/16. Thus I request that delegations, without prejudice to any statements they may wish to make, direct their comments and suggestions to topics, as follows:
