Excellency,

The General Assembly, by its resolution 65/240 of 24 December 2010, decided to hold a one-day high-level meeting of the General Assembly to commemorate the tenth anniversary of the adoption of the Durban Declaration and Programme of Action. By its resolution 65/279 of 13 June 2011, the General Assembly further specified the scope, modalities, format and organization of the high-level meeting to be held on Thursday, 22 September 2011.

In paragraph 5 of resolution 65/279, the Assembly invited "the President of the General Assembly to draw up a list of representatives of civil society organizations, including non-governmental organizations active in the field of racism, racial discrimination, xenophobia and related forms of intolerance and, taking into account the principle of equitable geographical representation, to submit the list to Member States for consideration on a no-objection basis, for participation in the high-level meeting".

I have the honour to herewith transmit the list for your consideration. If I do not hear from you by 25 August, I will take it that there is general agreement on the list.
