Excellencies,

As the co-facilitators of the “Intergovernmental process of the General Assembly on strengthening and enhancing the effective functioning of the human rights treaty body system” we have the honor to enclose a list of non-governmental organizations that have not participated in the intergovernmental process so far and that are without ECOSOC consultative status, which are seeking to participate in the **civil society forum** on 26 February 2013 and in the intergovernmental process when there is participation of non-governmental organizations.

We are sharing this information in accordance with our non-paper on the process of consultations which was sent to all Member States and Observers by our letter dated 11 July 2012. In the non-paper it is stated that “where there is participation of non-governmental organizations, those non-governmental organizations that have ECOSOC consultative status will be able to directly participate while a list of those without such status will be submitted to Member states for their consideration on a non-objection basis.”

In accordance with the above mentioned modalities of participation of non-governmental organizations in the “Intergovernmental process of the General Assembly on strengthening and enhancing the effective functioning of the human rights treaty body system” the co-facilitators will wait until 25 February 2013 before proceeding with the accreditation of the non-governmental organizations on the list.
