In my capacity as Chair of the Ad Hoc Working Group on the revitalization of the work of the General Assembly during the 67th session, I wish to thank all delegations for their participation in the first meeting of the Ad Hoc Working Group held on April 2nd, 2013, that was dedicated for general discussion.

Following the agreed programme of work, I would like to invite you to the second meeting of the Ad Hoc Working Group to be held from 10:00 a.m. to 1:00 p.m. on Monday, 29 April 2013, in Conference Room 4 (NLB). This meeting will be the first thematic meeting of the Ad Hoc Working Group to discuss the “Role and Authority of the General Assembly”, as well as its relationship with other principal organs of the United Nations and other Groups outside the United Nations.

As agreed during the first meeting of the Ad Hoc Working Group on April 2nd, 2013, the draft updated inventory/chart of General Assembly resolutions on revitalization has been restructured by splitting it into two parts, as follows:

- The first part contains the provisions that have been agreed since the 63rd session, in addition to the unimplemented provisions, in order to focus on their follow up.
- The second part includes the implemented provisions both those that required one-time action and those with ongoing implementation, in order to keep track of previous achievements and provide the means to compare and learn from past experiences.

I encourage you to present your views and proposals on the issues related to the “Role and Authority of the General Assembly” in the updated inventory/chart during the meeting of the Ad Hoc Working Group on Monday, 29 April 2013. The revised updated inventory/chart, along with the related explanatory note by the Chair, is posted on the web-site of the President of the General Assembly: <http://www.un.org/en/ga/president/67/issues/index.shtml>.

I would highly appreciate your active participation at this meeting and look forward to a productive discussion.
