## **Draft decision**

### **Intergovernmental committee of experts on sustainable development financing**

The General Assembly, recalling its resolution 66/288 of 27 July 2012, in which it endorsed the outcome document of the United Nations Conference on Sustainable Development, entitled “The future we want”, and resolutions 67/203 and 67/199 of 21 December 2012, to that end:

(a) Decides to establish an intergovernmental committee of experts on sustainable development financing;

(b) Welcomes the membership of the intergovernmental committee of 30 experts on sustainable development financing as nominated by the five United Nations regional groups and as listed in the annex 1 to the present decision;

(c) Decides that regional groups shall be authorised to appoint replacements<sup>1</sup> of those experts from their Group who cease to be a member of the Committee, effective upon notification to the President of the General Assembly and the Committee from the relevant regional Group;

(d) Requests the Secretary General to provide the necessary support for the Committee’s work until the completion of its work in 2014.

(e) Requests that the Committee hold its first meeting no later than August 2013.
