Martin Guzman is a Research Associate at Columbia University Graduate School of Business, an Associate Professor at University of Buenos Aires, and a Senior Fellow at the Centre for International Innovation. He is a co-chair of Columbia University Initiative for Policy Dialogue's Taskforce on *Debt Restructuring and Sovereign Bankruptcy*, and a member of the INET Research Group on "Macroeconomic Efficiency and Stability". He is a co-editor of the *Journal of Globalization and Development*. He holds a PhD in Economics from Brown University. His research fields are Macroeconomics and Economic Development. He has published extensively on the field of sovereign debt.

Jane Brauer is a director and senior GEM fixed income quantitative strategist, responsible for identifying relative value and trade strategies in external debt and derivatives. Brauer ranked #1 in Latin America Sovereign Debt in the 2013, 2014, and 2015 Institutional Investor surveys. Prior to joining the firm in 1992, she worked in a variety of fixed income research and marketing positions at Goldman Sachs, Credit Suisse, First Boston and Citibank.

Mark Flanagan is an Assistant Director of the IMF's Strategy Policy and Review Department (SPR). Prior to his time in SPR, he was a mission chief or manager for several Fund-supported crisis programs, including Ukraine, Iceland, and Greece.
