Mr. Chairman,

1. Thank you for giving my delegation the floor again and to speak to this very

important item.

2. Tonga welcomes the report of the Secretary-General, Strengthening and

coordinating United Nations rule of law activities as contained in document

A/73/253 and we applaud the ongoing activities of the organization in ensuring

peace and fostering the rule of law at the national, regional and international levels.

Mr. Chairman,

3. The United Nations is the epitome of global multilateralism, a strong platform for

our collective efforts to jointly address and achieve the objectives of the United

Nations' Charter. It is only through multilateralism steered by the United Nations

that we can endeavor to foster human rights, peace and security. Our common

roadmap, the Agenda 2030 and its Sustainable Development Goals, provide

guidance in building a sustainable future for current and future generations where

no one is left behind.

4. In so saying, we reaffirm the instrumental role that the rule of law plays in realizing

the principles of the United Nations' Charter, in particular, through equal access to

justice, good governance and transparency. These are crucial elements for, inter-

alia, fostering peace, sustainable development, gender equality, inclusive

economic growth, environmental protection and the eradication of poverty.

Mr. Chairman,

5. Tonga attaches great importance to the rule of law at the national and international

levels, where we appreciate its role as the mainstay of peaceful, secure, fair and

stable societies. To that end, Tonga's Constitution calls for maintaining the

principles of the rule of law at all times, in alignment with SDG 16. Tonga

acknowledges that the rule of law is founded on the principles of equality before

the law, judicial independence and access to justice.

6. In an effort to promote access to justice, particularly for our most vulnerable

groups, Tonga, with the assistance of Australia and Sweden through the Pacific

Community, established a Community Legal Aid Center, which provides free legal

assistance to survivors of domestic violence. The issue of equal access to justice

may even be considered a sub-topic under this item given its central importance

to the rule of law.

Mr. Chairman,

7. The codification and development of international law is vital in promoting the rule

of law at the international level as highlighted in Part C of the Secretary-General's

report. In so saying, Tonga as a large ocean developing state, welcomes the

commencement of the intergovernmental conference on the conservation and

sustainable use of marine biological diversity of areas beyond national jurisdiction,

pursuant to UNGA Resolution 72/249. The timely work of the Conference will

ensure a robust and binding agreement is concluded by 2020.

seventieth session to include an important topic for my delegation, "Sea-level rise

in relation to international law", in its long term programme of work, and we look

forward to the Commission moving this topic to its active work programme and

consideration. For a small island developing State like Tonga and coastal States

generally, sea-level rise has implications on the sovereignty of States and has yet

to be addressed by international law in any meaningful way. Pronouncement by

the Commission would give guidance to our discussions in this Committee and

decisions at the General Assembly. We will speak more to this important and

pressing issue when the Committee considers the report of the Commission later.

9. Tonga welcomes all of the sub-topics proposed in the Secretary-General's report

for the Committee's consideration for in-depth study as highlighted in Part III(B) of

the Secretary-General's report, in particular, the implementation of the rule of law

elements of the 2030 Agenda for Sustainable Development and sharing of best

practices. We note the intricate value of each sub-topic for pursuing, maintaining,

and fostering the rule of law, and thereby supporting international peace and

security.

Tonga is grateful for the support of Australia, New Zealand, Sweden, UNDP,

regional organisations and civil society and other development partners, in our

efforts to improve access to justice. These partnerships have resulted in a justice

sector-wide and targeted support projects being implemented in Tonga. These are

aimed at strengthening our courts through improving its record management

capacity, the judicial capacity on managing family and juvenile cases, and the

notice in mainstranging gooder and human rights notices into its work

police in mainstreaming gender and human rights policies into its work.
