As he concludes his mandate as UN Special Rapporteur this fall, he examines the contributions of his previous reports to the achievement of the targets of

Sustainable Development Goal 16 and identifies the outstanding challenges and tasks for States in the area of justice.

These challenges can be grouped into three main areas: the influence of authoritarianism on judicial independence and the role of lawyers; the challenges posed by corruption for the justice system; and access to justice for all.

In response to the report of the UN Special Rapporteur, the Director of the Hague Institute for International Law, Sam Muller, will present the findings of a recent study undertaken by HilL on access to justice as a key prerogative for just and peaceful societies (SDG16)
