### Republic of Korea

### I. Basic Legal Rule

#### 1. Relevant national legal rule

The Republic of Korea has incorporated the principle of universal jurisdiction into domestic legislation by allowing prosecution of certain crimes that did not take place in the territory of the Republic of Korea by foreign nationals.

The Criminal Act extends criminal liability under universal jurisdiction for crimes of trafficking in persons to implement the United Nations Convention against Transnational and Organized Crime by amending Article 296-2 (Universality) of the Criminal Act in 2013.

## **Criminal Act Article 296-2 (Universality)**

Articles 287 through 292 and 294 shall apply to aliens who commit crimes outside the territory of the Republic of Korea.

\* Article 287 (Kidnapping or Abduction of Minors), Article 288 (Kidnapping, Abduction, etc. for Purpose of Indecent Acts, etc.), Article 289 (Trafficking in Persons), Article 290 (Inflicting or Causing Another's Bodily Injury while in Kidnapping, Abduction, Trafficking in Persons, Transportation, etc.), Article 291 (Killing Another or Causing Death of Another while in Kidnapping, Abduction, Trafficking in Persons, Transportation, etc.), Article 292 (Receiving, Harboring, etc. of Person Kidnapped, Abducted, Trafficked, or Transported), Article 294 (Attempts)

The Republic of Korea also enacted the Act on Punishment of Crimes under Jurisdiction of the International Criminal Court to implement the Rome Statute of the International Criminal Court in 2011, the Act on Punishment for Damaging Ships and Sea Structures to implement the United Nations Convention on the Law of the Sea in 2021, and the Act on Counter-terrorism for the Protection of Citizens and Public Security to implement the related resolutions of the United Nations Assembly and Security Council in 2021. The universality clauses provide a basis for the exercise of universal jurisdiction to related crimes when these have been committed abroad by foreign nationals.

Act on Punishment of Crimes under Jurisdiction of the International Criminal Court Article 3 (Scope of Application)

(5) This Act shall apply to any foreigner who commits the crime of genocide, etc. outside the territory of the Republic of Korea and resides in the territory of the

## Republic of Korea.

Act on Punishment for Damaging Ships and Sea Structures Article 3 (Scope of Application to foreigners)

- 3. A foreigner who commits an offense specified in any provision of Articles 5 through 13 outside of the territory of the Republic of Korea, but stays within the territory of the Republic of Korea.
- \* Article 5 (Violence, Threat, Battery, and Murder), Article 6 (Seizure of Ships), Article 7 (Destruction of Ships), Article 8 (Destruction, etc. of Equipment or Facilities Related to Operation of Ships), Article 9 (Installation or Loading of Dangerous Objects), Article 10 (Communication of False Information), Article 11 (Attempts), Article 12 (Murder, Manslaughter or Injury by Battery during Seizure of Ship), Article 13 (Criminal Coercion)

Act on Counter-terrorism for the Protection of Citizens and Public Security Article 19 (Universality)

A foreigner who commits a crime provided for in Article 17 outside the territory of the Republic of Korea shall also be subject to the application of domestic Acts.

\* Article 17 (Crimes of Forming Terrorist Groups)

#### 2. Judicial Practice

The Supreme Court applied the Aviation Safety Act to a case of hijacking of foreign aircraft by foreign nationals. The Supreme Court stated that the courts of the Republic of Korea can exercise jurisdiction as a landing country with the country of aircraft registration considering the Convention on Offences and Certain other Acts Committed on Board Aircraft and the Convention for the Suppression of Unlawful Seizure of Aircraft. II. Conditions, restrictions of limitations to the exercise of jurisdiction - Constitutional and domestic legal framework

The Act on Punishment of Crimes under Jurisdiction of the International Criminal Court Article 3 (5) and the Act on Punishment for Damaging Ships and Sea Structures Article 3, 3 conditions their universal jurisdiction on the presence of the perpetrator in the territory of the Republic of Korea after the commission of the alleged offence. Therefore, investigation authorities will not open an investigation where the alleged perpetrator is not present in the country or where the alleged perpetrator has not been identified.
