**Measures to Eliminate International Terrorism**

**Mr. Chair,**

Congratulations on your election as the Chair of this Committee. Please rest assured of our full support and cooperation.

We also wish to thank the Secretary General for his report contained in document A/79/99.

Indonesia aligns itself with the statements delivered by delegations of Cambodia, Iran, and Saudi Arabia; on behalf of ASEAN, NAM, and the OIC respectively.

**Mr. Chair,**

Acts of terrorism have evolved rapidly.

The use of ICT and emerging technologies further augment terrorists' actions ... in terms of planning, recruiting, organizing, and funding.

Against this backdrop, allow me to convey three points.

**FIRST**, enhancing cooperation in combating terrorist financing.

Without funding, terrorist organizations would struggle to recruit, train, plan, and execute attacks.

Identifying and disrupting these financial networks is one of the most effective ways to weaken terrorist organizations ... and limit their reach and capabilities.

As a member of FATF, Indonesia continues to improve and strengthen its Anti-Money Laundering and Countering the Financing of Terrorism regime.

The Law No. 9 Year 2013 provides a robust framework for preventing and eradicating terrorist financing by ...

- ➔ not only criminalizes all forms of financing for terrorism,
- ➔ but also grants the authority the power to identify, freeze, seize, or confiscate assets linked to terrorist financing.

This legislation reflects Indonesia's commitment to disrupt and dismantle terrorist financing networks.

**SECOND**, strengthening collaboration.

It is important to implement a whole-of-government and whole-of-society approach to prevent and combat terrorism and violent extremism conducive to terrorism ...

- ➔ including by addressing the drivers of terrorism, in accordance with international law.

Our counterterrorism strategy must be built upon the principle of multi-stakeholder engagement ...

- ➔ involving government, civil society, and international partners, including regional groupings.

We must enhance our partnership with the UN Global Counter-Terrorism Coordination Compact, as well as regional organizations.

**THIRD**, revitalizing efforts towards the conclusion of a Comprehensive Convention on International Terrorism.

The CCIT will be an effective tool in our collective efforts to prevent and combat terrorism.

Indonesia supports the Working Group established by the Committee to finalize the process on the Draft CCIT.

We also encourage all States to make every effort to reach consensus in resolving the outstanding issues, including those related to the legal definition of terrorism.

The current CCIT draft offers a solid foundation upon which to continue our discussions and finalize the drafting process.

**Mr Chair,**

Just a week ago, we adopted the Pact for the Future where we resolve to pursue a future free from terrorism.

Indonesia is committed to tackling the global menace of terrorism in all its forms and manifestations, while upholding the principles of international law and the UN Charter.

We are confident that through shared values and commitments, we can and will prevail over the threat of terrorism.
