The Permanent Mission of the Islamic Republic of Iran to the United Nations presents its compliments to the Secretariat of the United Nations and would like to refer to the Notes of the Legal Counsel on behalf of the Secretary-General of the United Nations No. LA/COD/4 and No. LA/COD/4, respectively dated 13 February 2024 and 4 January 2023 regarding the General Assembly resolution 77/108 entitled "Consideration of effective measures to enhance the protection, security and safety of diplomatic and consular missions and representatives". In accordance with paragraph 11 of resolution A/RES/77/108, the Permanent Mission of the Islamic Republic of Iran to the United Nations would like to submit relevant information as appended to the present note.

The Permanent Mission of the Islamic Republic of Iran would like to hereby request that the information attached to this note be included in the report of the Secretary-General of the United Nations to be submitted to the General Assembly at its seventy-ninth session in accordance with the resolution A/RES/77/108.

The Permanent Mission of the Islamic Republic of Iran to the United Nations avails itself of the opportunity to renew to the Secretariat of the United Nations the assurances of its highest consideration.

Afghanistan

On 11 April 2022, unknown individuals set the doors of the Consulate-General of the Islamic Republic of Iran in Herat on fire, inflicted damage to the CCTV cameras and walls of the building of the Consulate-General. The attackers were of Afghan nationality. Despite multiple follow-ups, no one was arrested and no report on police investigation was announced.

Austria

On 11 October 2022, the First Counsellor and Third Secretary of the Permanent Mission of the Islamic Republic of Iran to the United Nations in Vienna were subject to harassment, hatred, insult, and life threat by an individual who was illegally filming the aforementioned personnel in front of the Mission. On 12 and 20 December 2022, the same individual and his accomplice repeated same violation with the same condition against other members of the mission. On 16 December 2020, the family members of the Personnel were subject to harassment, hatred, insult, and life threat by the same individual in the shopping malls around Vienna. Despite multiple follow-ups, no report on police investigation was announced concerning these violations.

On multiple occasions, from September 2022 to March 2023, the Representatives of the Islamic Republic of Iran sent to special missions in Vienna to participate in UN meetings and sessions were harassed, insulted and threatened. In addition, on one occasion paint has been daubed on the building of Residence of the Ambassador and Permanent Representative of the Islamic Republic of Iran to the United Nations in Vienna. Despite multiple follow-ups, no report on police investigation was announced, yet the police forces have been deployed full-time in front of the residence.

Belgium

On 22 September 2022, a group of pro PJAK Terrorist Organization gathered in front of the Embassy of the Islamic Republic of Iran in Brussels to hold a demonstration. While carrying anti-Iranian placards and photos, shouting insulting slogans against the Iranian Government, and threatening statements against Embassy staff, they started to throw big stones at the Embassy's building, which caused damage to the walls and the windows security shutters of the first floor. The police forces present at the site were unwilling or unable to prevent the attackers from these aggressive acts of vandalism. Despite multiple follow-ups, no report on police investigation was announced.

On 23 September 2022, at 02:05 a.m. three masked terrorists threw ten handmade Molotov cocktails into the Embassy's yard. Consequently, the yard, two diplomatic vehicles belonging to the Mission, a number of trees, and outdoor car parking shades were burnt. Due to the spread of incendiary substances, oil and gasoline from cars, the yard and the Embassy building were contaminated and multiple serious material damages were inflicted to the Embassy. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State. Although the presence of Police forces to protect the Embassy increased for a few months, their number and the hours of their presence decreased gradually and ended eventually.

In the afternoon of the same day (23 September 2022), while a group of pro PJAK Terrorist Organization gathered in front of the Iranian Embassy in Brussels, an unknown individual daubed red paint on the façade, walls and entrance door of the Embassy, which also caused damage to the doorbell camera. The police forces present at the site were unwilling or unable to prevent the act of vandalism. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State. In a similar incident on the same day, a group of attackers committed the same act of vandalism. Though the perpetrators were arrested, they were released a few hours later.

On 27 September 2022, at 00:30 a.m. three unknown individual daubed red paint on the entrance door and walls of the consular section of the Embassy, threw paint balloons in the Embassy's yard, and wrote threatening slogans ("death is on the way") on the walls of the consular section of the building. The perpetrators filmed their acts of vandalism by cellphones and published them on social media. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 13 October 2022, two individuals (a male and a female) approached the entrance door of the Embassy with a bag containing human feces in their hands, daubed it on the door and wall plate of the Embassy. The police forces present at the site did not prevent the perpetrators from these heinous acts of vandalism. Only after they completed their offence, they were arrested. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 29 October 2022, an unknown individual attached two leaflets to the back door of the Embassy containing baseless accusations against the Iranian Government and the staff of the mission. The police was not present during the perpetration of this violation. No report on police investigation was announced.

On 3 November 2022, unknown individual(s) drew threatening graffiti on the walls of the building of residence of Iran's Ambassador in Brussels in large dimensions containing baseless accusations against him. Though the police was not present during the perpetration of this act of vandalism, while contacting the police to report the violation, it was revealed that they were aware of this violation, yet did not take any action to clean the wall or even inform the Embassy about the existence of this graffiti. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 6 and 27 November 2022, three individuals (two females and one male), sprayed red paint on the entrance door, doorbell cameras, wall plate, walls and fences of the Embassy, left red handprints on the site and attached hair on the back door of the Embassy. The police was not present during the perpetration of this violation. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 29 January 2023, two individuals approached the back door of the Embassy, wrote baseless slogans against the Iranian Government with red spray, and left red handprints on the site. The perpetrators filmed their acts of vandalism by cellphones and published them on social media. The police was not present during the perpetration of this violation. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 3 April 2023, unknown individual(s) wrote slogans on the main entrance of the Embassy in large dimensions. The police was not present during the perpetration of this violation. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 11 February 2024, two individuals installed a large banner on the fences of the Embassy. The police was not present during the perpetration of this violation. No report on police investigation was announced.

On 17 February 2024, unknown individual(s) used a saw to cut the CCTV camera installed at the top of the Embassy's door and stole it. The Embassy's electricity was disrupted for a short time. The police was not present during the perpetration of this violation. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

Bosnia and Herzegovina

On 3 June 2022, two individuals assaulted the Embassy's Third Secretary and his spouse, and consequently rubbed their bags containing their belongings including their identity documents. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 18 January 2023, burglars broke into the garage of the residence of the Embassy's First Secretary and stole his vehicle. Their attempt to break into the main building of residence was unsuccessful. In a similar incident on 27 August 2023, burglars broke into the garage of the residence of the Embassy's diplomatic staff and stole a bicycle. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

Denmark

On 5 September 2022, unknown individuals threw three Molotov cocktails inside the consular section of the Iranian Embassy in Copenhagen who escaped from the scene thereafter. Consequently, some parts of the wall, garden and fences of the building were burnt. The damages were compensated by the receiving State.

On 19 September 2022, two individuals daubed paint on the wall, fence door, yard of the Embassy, wrote baseless accusations on the walls, burnt the flag of the Islamic Republic or Iran, and filmed their acts of vandalism by cellphones. Consequently, the damages inflicted to the property and premises were compensated by the receiving State.

On 7 October 2022, a 32-year-old man of Iranian nationality, armed with a knife, illegally broke into the Embassy's premises, threatened the staff, vandalized the premises of the Embassy and property of its staff including their vehicles. The assailant in an unsuccessful attack towards the Ambassador, injured a Member of the Mission. With police intervention, the assailant was arrested, tried in the court, and subsequently sentenced to imprisonment. Consequently, the damages inflicted to the property and premises were compensated by the receiving State and insurance companies. Protection measures were intensified by the receiving State from 7 October 2022.

On 27 May 2022, 13 July 2022 14 July 2022 18 November 2022, 24 November 2022, 2 March 2023 and 25 May 2023, unknown individuals by setting up camps in front of the consular section of the Embassy, shouted offensive and vulgar slogans, illegally filmed clienteles and members of the mission to prevent them from entering into the building. While the police have attempted to prevent the perpetrators from engaging in physical violence, the verbal assaults had always continued. In order to preserve the safety and security of the Mission, in many cases, the receiving State has avoided issuing of permits for gatherings to be held in front of the Embassy buildings and has directed the disruptors to other parts of the city.

Georgia

On 3 November 2022, a group of 15 individuals attacked and forcibly broke into the building of the Ferdowsi Educational Complex of the Iranian Embassy in Tbilisi as well as the building of residence dedicated to the members of the Iranian Special Mission. The perpetrators lowered the flag of the Islamic Republic of Iran from the top of

building, and afterwards disrespected the flag and stole it. Although the authorities of the receiving State were warned about this imminent aggression, no protective measure was adopted. On the same day, the First Secretary of the Embassy was beaten by two of the assailants. In addition, a group of individuals stopped and surrounded the vehicle of Third Secretary of the Embassy, blocked his path, insulted and threatened him to death. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 27 July 2023, an individual (female) vandalized and damaged the vehicle of a member of the diplomatic staff of the Iranian Embassy in Tbilisi. While she removed the vehicle's license plate, the police prevented her from stealing it. Despite multiple follow-ups and revealing the Identity of the assailant to the Georgian authorities, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

Iraq

The Islamic Republic of Iran in its previous reports submitted earlier under this agenda item has referred to the serious damages inflicted to its Consulates-General in Basra, Karbala and Najaf, a summary of which will be recapitulated below:

On 7 September 2018, about 30,000 Iraqi demonstrators staged an organized rally in front of the Iranian Consulate General in Basra when 200 of the protesters proceeded to an unimpeded break-in in spite of presence of a disproportionate 50 security personnel who unfortunately were passive observers of what was unfolding. The intruders run amok about three hours in the premises up to 8 p.m. engaging in destruction of all property, documents, devices and equipment, chanting anti-Iranian slogans, disrespecting Iran's flag with torching it and ultimately burning the whole Consulate General building down.

On 3 November 2019, a number of Iraqi citizens intruded to the Consulate General of the Islamic Republic of Iran in Karbala and engaged in burning and destruction of the premises, incurring heavy damage in the process.

On 27 November 2019, the Islamic Republic of Iran's Consulate General in Najaf was assailed by rioters during which buildings, vehicles, property and other assets sustained heavy damage.

Despite the willingness and assurances that have been expressed by the Iraqi authorities during bilateral meetings, including the meeting between the delegation of the Ministry of Foreign Affairs of the Islamic Republic of Iran and the authorities of the Ministry of Foreign Affairs of the Republic of Iraq in Baghdad on 16 June 2022 to settle these incidents by preventing similar incidents in future, taking necessary precautionary measures and providing compensation to the Iranian Government for the damages inflicted to its properties and premises as well as the affected private owners of the

premises, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State. Moreover, 30 notes verbale sent to the Iraqi authorities were left unanswered, namely, Notes no. 200/991547 dated 07/09/2018, no. 641/322/4931884 dated 10/09/2018, no. 200/997438 dated 15/09/2018, no. 200/997718 dated 15/09/2018, no. 200/1007060 dated 26/09/2018, no. 200/228692 dated 16/10/2019, no. 641/322/247087 dated 13/8/1398, no. 200/247098 dated 04/11/2019, no. 200/274295 dated 28/11/2019, no. 641/322/281751 dated 05/12/2019, no. 516/352191 dated 09/02/2020, no. 516/374680 dated 01/03/2020, no. 200/389657 dated 17/03/2020, no. 516/414081 dated 27/04/2020, no. 516/429735 dated 13/05/2020, no. 516/545718 dated 12/09/2020, no. 200/597861 dated 04/11/2020, no. 670/658136 dated 10/01/2021, no. 200/718924 dated 09/03/2021, no. 752472 dated 18/04/2021, no. 754515 dated 20/04/2021, no. 771977 dated 09/05/2021, no. 641/852391 dated 27/07/2021, no. 1029174 dated 06/01/2022, no. 641/1156674 dated 27/04/2022, no. 641/1228213 dated 26/06/2022, no. 641/1235673 dated 02/07/2022, no. 641/1383441 dated 06/10/2022, no. 641/1558836 dated 11/04/2023, no. 641/1770191 dated 02/10/2023, and no. 641/1899905 dated 11/01/2024.

Ireland

On 8 October 2022, an assailant wrote slogans on the walls of the Iranian Embassy in Dublin, removed the Embassy's signboard, and destroyed the doorbell. Subsequently, the perpetrator was arrested on 17 October 2022, convicted and fined to pay 750 € by the Court as part of the damage caused to the Embassy, and banned from travelling into a certain distance from the Embassy. After this incident, Police presence during the gatherings has become more serious, the number of gatherings became limited and occurred at a greater distance from the front door of the Embassy.

On 14 October 2022, unknown individual(s) wrote slogans and baseless accusations on the walls of the building of residence of the Iranian Ambassador in Dublin. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 8 April 2023, 28 April 2023, 12 May 2023, and 4 July 2023, unknown individuals wrote slogans on the walls of the Iranian Embassy in Dublin and removed the Embassy's signboard. Subsequently, the perpetrators were arrested, yet neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State. However, it seems that the conviction of the offender of the violation occurred on 8 October 2022, and the arrest of the other perpetrators have had a significant impact on the control of violations. No similar violation has been committed after interventions by the receiving State.

Italy

In the mid October 2022, unknown individuals daubed paint on the walls of the Iranian Embassy in Rome. Despite multiple follow-ups, neither was any reports announced on

police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

In March 2022, unknown individuals in front of the Iranian Ambassador's residence harassed, insulted and prevented guests from participating in the Iranian New Year's Eve ceremony. Despite the follow-ups, no report on police investigation was announced.

On 11 February 2023, unknown individuals in front of the Iranian Ambassador's residence harassed, insulted and disturbed the guests, members of the mission as well as their family members who were participating in the Iranian National Day Ceremony. Despite the follow-ups, no report on police investigation was announced.

In January 2023, unknown individuals harassed, insulted and disturbed members of the mission who were gathered in front of the Embassy's School in Rome. Despite the follow-ups, no report on police investigation was announced.

In November 2023, unknown individuals harassed, insulted, disturbed and shouted baseless accusations against the Political Deputy of the Ministry of Foreign Affairs of Iran while he was paying a visit to the Istituto Affari Internazionali (IAI) in Rome. Despite the follow-ups, no report on police investigation was announced.

Netherlands

On 6 October 2022, two individuals were arrested by police who had reportedly planned to attack the ambassador and set the Iranian Embassy on fire.

On 8 October 2022, when a member of the Mission was leaving the building of residence of the Ambassador, noticed that at least three vehicles were waiting outside, keeping watch for the ambassador or other individuals stationed at the residence to leave the building. After the said member of the Mission left the residence, one of the vehicles chased him, disturbed him on the highway in a way so that he was forced to return back residence building for his safety.

On 19 October 2022, a masked individual daubed red paint on the entrance door, walls, fences, wall plate, and signboard of the Embassy, as well as the entrance door of the consular section. The perpetrator was arrested and the police made necessary arrangements with the municipality to clean the walls and other places daubed with paint.

On 18 November 2022, an unknown individual while shouting offensive and vulgar insults threw eggs at the windows and the entrance door of the Embassy, and threatened the members of the mission with a knife to death. Thereafter by using the metal barriers he managed to break the lock door, forcibly enter into the Embassy's yard, and destroy the CCTV Camera. Subsequently, the perpetrator was arrested and police made necessary arrangements with a company to change the lock on the wooden door of the Embassy. The perpetrator was fined to pay 400 € for his offence.

On 13 December 2022, two individuals while shouting offensive and vulgar insults daubed red paint on the Embassy's building. The perpetrators were arrested by police.

On 14 January 2023, the Iranian Embassy received two e-mails from unknown sender threatening to set the Embassy on fire and to shoot at the members of the mission. The authorities started investigations to identify the identity of the sender of the emails to the Embassy. The trial of the perpetrators had to take place in December 2022, yet the result of the proceedings or the identity of the senders were not revealed to the Embassy.

On 7 January 2023, two individuals of Dutch nationality without any prior permission were taking videos from the Embassy building with professional cameras and recording the entry and exit of people from the Embassy. Despite the follow-ups, the Police responded that filming is not an offence under the Dutch law; however, considering the violations committed against the members of the mission, filming and recording could be used for the purpose of subsequent harassments and violations.

On 10 July 2023, an individual by help of his van and a ladder, entered the yard of the Embassy's school. Thereafter, he cut the flagpole with an angle grinder and attempted to set the flag on fire. In order to enter the Embassy's building, he inflicted damage to the wooden front door, its lock and doorbell camera. He also installed placards containing baseless accusations in the Embassy's yard. The intruder was arrested by police.

On 23 August 2023, unknown individuals attached leaflets and placards on the fences of the Embassy's building containing baseless accusations against the Iranian Government and the staff of the Mission. The police got present at site and forced them to remove the leaflets and placards.

The abovementioned offences disrupted the efficient performance of the functions of the diplomatic mission, disturbed the mental peace of members of the mission as well as their family members and impaired their dignity. Despite follow-ups, no measures were adopted to compensate the damage by the authorities of the receiving State. Moreover, the security measures adopted by the receiving State are not sufficient and should be intensified.

Norway

On 27 September 2022, a group of around 15 members of the Komala terrorist group blocked the path of a family member of the staff of the Mission in front of the subway station, questioned him about any affiliation with the Embassy, and brutally slapped him in the face. Despite the follow-ups, no report on police investigation was announced and nobody was arrested in this regard. Surprisingly, two individuals from the aforementioned terrorist group, set up a 24-hour camp in front of the Embassy, without any action or prevention from the police. Moreover, some of the members of the aforementioned terrorist group filmed and identified the surroundings of the Embassy before and after the attack.

On 27 September 2022, a group of around 15 members of the Komala terrorist group passed the policemen stationed at the beginning of the alley, and threw eggs and stones at the building of the Embassy, vandalized the fences of the building, two vehicles belonging to the Embassy and a vehicle belonging to the staff of the mission. The damages were compensated by the receiving State, yet the report on police investigations has to be announced.

Romania

On 17 January 2022, while a member of the diplomatic staff was entering the Embassy with his vehicle, an assailant entered the Embassy yard, threatened the diplomatic agent to death and hit the vehicle's windshield several times with a belt. Thereafter, he was arrested and taken outside the Embassy. The assailant was fined by police for disturbing public peace and order, compelled to apologize for his offence in front of the police. The authorities of the receiving State announced that appropriate security measures have been taken to prevent occurrence of similar incidents.

South Africa

On two occasions, the residence of a member of the diplomatic staff has been rubbed. In addition, the mobile phone of the Consul of the Embassy has been stolen. Despite the follow-ups, no report on police investigation was announced.

Spain

On 15 December 2022, a member of the consular section of the mission was harassed and threatened by an individual who thereafter entered the consular section of the building to repeat and continue his offence. Similar incident has occurred previously by the perpetrator against the aforementioned member of the mission. The perpetrator was arrested by police. Despite the follow-ups, no report on police investigation was announced.

In the mid October 2022, on two occasions, unknown individual(s) wrote baseless accusations and anti-Iranian slogans on the walls of the Embassy during mid-night. On one occasion, the signboard of the Embassy was removed and destroyed. Despite the follow-ups, no report on police investigation was announced.

These offences disrupted the efficient performance of the functions of the diplomatic mission, disturbed the mental peace of members of the mission as well as their family members and impaired their dignity.

Sudan

With the scourge of civil war in Sudan after 16 April 2023, the properties of the Embassy and residence of the Head of the Iranian Mission in Sudan have been looted. Due to the lack of access and presence in the country of the receiving State, an accurate assessment of the damages is not possible. These violations were allegedly perpetrated by Rapid Support Forces (RSF).

Sweden

On 23 January 2024, while a diplomatic vehicle was entering the Embassy, several individuals entered the front area of the Embassy, prevented the doors from shutting, shouted insults and threatened the members of the mission. One of the intruders attacked a member of the Mission by punching him in the face, which caused him fall on the ground and start to bleed. After around 15 minutes, the police arrived and arrested five of the intruders. Reportedly, the perpetrators had no permit to gather in front of the Embassy. The investigation by police continues and the accused are summoned to make presence before the court. After this incident, police forces were present 24 hours a day in front of the Embassy for almost 15 days.

Switzerland

In October 2022, two individuals entered the Iranian Embassy in Bern, lowered and disrespected the flag of the Islamic republic of Iran. The perpetrators were found guilty by the court.

On two occasions, in the mid-October 2022 and on the night of 11 February 2023, a group of individuals daubed paint on the building of the Embassy. Moreover, during the gatherings held in October 2022 in front of the Embassy, the members of the mission and their family members were threatened to death. The court order issued against the perpetrator who lowered and disrespected the flag, prevented similar incidents by the disruptors in subsequent gatherings in front of the Embassy.

Syria

On 25 December 2023, at 16:20 hours, the Israeli occupying regime launched a missile attack from the direction of the occupied Syrian Golan that hit the residence of Razi Mousavi, a military advisor and the member of the mission of the Islamic Republic of Iran in Damascus, leading to his martyrdom.

On 20 January 2024, the Israeli regime targeted a residential building in Damascus through missile strikes, resulting in the martyrdom of many civilians as well as five Iranian military advisers: Hojjatollah Omidvar, Ali Aghazadeh, Hossein Mohammadi, Saeed Karimi, and Mohammad Amin Samadi.

On 1 April 2024, at 16:45 hours, the Israeli occupying regime perpetrated a heinous and abhorrent terrorist attack against the diplomatic premises of the Islamic Republic of Iran in Damascus by intentionally targeting the Iranian diplomatic premises with missile airstrikes from the direction of the occupied Syrian Golan, which resulted in the martyrdom and tragic loss of the members of the diplomatic mission, including seven anti-terrorism senior military advisors and the complete destruction of the diplomatic premises in question.

Turkey

On 7 February 2022, an assailant entered the Consulate-General of the Islamic Republic of Iran in Istanbul, vandalized its property with dagger and knife, and inflicted a damage approximately 100,000 liras to the building. Despite multiple follow-ups, no measures were adopted to compensate the damage by the authorities of the receiving State. Unfortunately, the General Criminal Court of Istanbul first issued an order on the temporary release of the accused. Subsequently, despite the defendant's absence and *in absentia*, sentenced him to a suspended punishment and thereafter he was released and discharged.

On 30 November 2023, three individuals while shouting offensive and vulgar insults forcibly entered into the building of the Consulate General of the Islamic Republic of Iran in Istanbul causing disorder, terror and violence for the members of the consular post and the clienteles of the post. Although the authorities of the receiving State were warned about this imminent aggression, no protective measure was adopted. Even after the delayed arrival of the police, not only the perpetrators were not arrested, but also they escaped easily without any resistance. Finally, after meeting with the Governor of Istanbul and filing an official complaint with the judicial authorities, the main perpetrator was arrested; however, the judicial proceedings did not lead to a tangible result. The perpetrator was eventually deported to Iran. Despite follow-ups, no measures were adopted to compensate the damage by the authorities of the receiving State.

United Kingdom

On 21 March 2022, unknown individual(s) inflicted damage to the CCTV camera, wall plate and entrance door of the building of the Iranian Embassy in London. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 17 April 2022, unknown individual(s) inflicted damage to the CCTV camera, removed the Mission's signboard and wall plate during the gathering of pro Komala terrorist group. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 8 May 2022, the pro Al-Ahwazi terrorist group and Al-Nidal terrorist group disrupted the efficient performance of the functions of the diplomatic mission by using a loudspeaker and shouting disrespectful slogans and insults. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 20 and 21 September 2022, unknown individual(s) inflicted damage to the windows, walls, and entrance door of the consular section of the Iranian Embassy in London. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 9 October 2022, unknown individual(s) occupied the balcony of the Iranian Embassy in London, lowered and disrespected the flag and removed the mission's signboard and wall plate. A number of intruders were arrested and released shortly thereafter. Despite multiple follow-ups, no measure was adopted to compensate the damage by the authorities of the receiving State.

On 23 October 2022, unknown individual(s) took photos from three members of the consular section of the Embassy and threatened them to death. Similarly, on 1 November 2022, unknown individual(s) took photos from four members of the diplomatic staff and threatened them to death. Despite multiple follow-ups, no reports on police investigation was announced.

On 17 November 2022, unknown individuals set up a 24-hour camp in front of the Embassy with permission of the authorities of the receiving State, disturbed the clienteles of the consular section, assaulted and threatened to kill them with knife, used a loudspeaker and shouted "We will kill you" (in Persian), provoked and incited violence, threatened to kill the consular staff of the mission, broke into the Embassy occupied the balcony, lowered and disrespected the flag of the Islamic Republic of Iran. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 12 December 2022, unknown individuals assaulted a member of the diplomatic staff and his child, disturbed and threatened them to murder with knife, used a loudspeaker for insulting, shouting offensive and vulgar slogans and threatening the members of the mission to death with knife. Also used a video projector to publish disgusting and insulting images against the Islamic Republic of Iran. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 14 February 2023, unknown individuals attacked the residence of the Ambassador of the Iranian Embassy by disturbing and assaulting the guests participating in the National Day Ceremony of Iran, insulted the members of the diplomatic staff and harassed them by recording videos and publishing them on social media. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 22 February 2023, unknown individuals attacked the residence of a member of the diplomatic staff of the Iranian Embassy by disturbing and assaulting him. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 14 and 19 March 2023, unknown individuals daubed paint on the windows and the entrance door of the Iranian Embassy in London. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 19 May 2023, unknown individuals disrupted the efficient performance of the functions of the diplomatic mission by threatening and intimidating the members of the mission. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 9 August 2023, unknown individual(s) inflicted damage to the diplomatic vehicle parked in the diplomatic parking lot in front of the Iranian Ambassador's residence. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 11 September 2023, unknown individuals threw paint balloons on the windows, façade, and entrance door of the Embassy and a diplomatic vehicle parked in front of the building in presence of police forces. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 16 September 2023, unknown individuals daubed paint on the Embassy's building, entrance door and windows. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

On 29 January 2024, unknown individuals threw eggs and daubed paint on the Embassy's entrance door and a diplomatic vehicle belonging to the Embassy, and disrupted the efficient performance of the functions of the diplomatic mission by threatening and intimidating the members of the mission. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

Despite the fact that the police forces were present 24 hours a day in front of the Embassy and its consular section since October 2022, all of the above-mentioned offences and violations have took place in front of police forces, without the police intervening or hindering the perpetrators from committing these offences.

Uruguay

On 13 October 2022, unknown individuals daubed paint on the walls of the Iranian Embassy in Monte Video. Despite multiple follow-ups, neither was any reports announced on police investigation, nor was any measure adopted to compensate the damage by the authorities of the receiving State.

It should be noted that all of the above-mentioned offences committed against the diplomatic missions, consular posts and representatives of the Islamic Republic of Iran have disrupted the efficient performance of the functions of the missions/posts, disturbed the mental peace of members of the missions as well as their family members and impaired their dignity.
