JUDGE GRAEME COLGAN, PRESIDING.

1. In our Judgment No. 2022-UNAT-1227,¹ we modified the UNDT's remedies' award by providing that Ms. Lekoetje was to receive a sum equivalent to one year's salary but from which the sum of USD 20,987.91 was to be deducted. That latter sum was intended to represent repayment to the Organisation of the benefits which she had received improperly. The Judgement was released to the parties on 18 May 2022.

2. On 6 June 2022, the Secretary-General filed an application for interpretation on the basis that this sum of USD 20,987.91 had in fact been deducted from Ms. Lekoetje's final entitlements when she ceased her employment with the Organisation so that our order, interpreted strictly, would require a further and unwarranted deduction. In her comments received on 8 June 2022, Ms. Lekoetje agrees with the Secretary-General's presentation of the background to the case and confirms that the sum of USD 20, 987.91 has already been deducted by the Organization from her final entitlements.

3. We accept that this is the position and, in these circumstances, it is appropriate to interpret our judgment as now requiring the payment to Ms. Lekoetje of a sum equal to one year's net base salary but without deduction and we so order.

Judgment

4. The application for interpretation is granted. The second sentence of paragraph 142 of Judgment No. 2022-UNAT-1227 is modified to read:

In substitution for those monetary remedies allowed by the UNDT we direct that Ms. Lekoetje is to have a sum equivalent to one year's net base salary pursuant to Article 9(1)(a) of the Appeal Tribunal Statute; and the UNDT's award of moral damages is set aside.
