Introduction

1. By joint motion filed on 31 March 2020, the Applicants request the Tribunal

to join their existing cases, namely Cases No. UNDT/GVA/2018/055,

114 and 115 for Applicant Williams and Cases No. UNDT/GVA/2018/059

and 063 for Applicant Patkar.

2. On 1 April 2020, the Respondent filed his response to the motion submitting

that the applications should not be joined.

3. Case No. UNDT/GVA/2018/055 is currently assigned to Judge Francesco

Buffa and Cases No. UNDT/GVA/2018/059 and 063 are currently assigned to

Judge Teresa Bravo. Cases No. UNDT/GVA/2018/114 and 115 were assigned

upon their filing to Judge Rowan Downing, whose term with the Tribunal expired

last year. In view of this, the undersigned Judges decide to issue the present

joint Order.

Consideration

4. In support of their motion, the Applicants submit that:

a. The facts of both cases are largely the same, and both

Applicants' causes of action arise from the same set of facts;

b. The legal issues of both cases are sufficiently similar to justify

Joinder;

c. Both Applicants assert similar grounds for relief; and

d. Judicial and financial economy would be served by joining the

cases.

5. The Tribunal notes that pursuant to Order No. 40 (GVA/2020) of

1 April 2020, the parties in Case No. UNDT/GVA/2018/055 are to submit their

closing statements next week. The Tribunal also recalls that pursuant to art. 19 of

its Rules of Procedure (Case management), it can "issue any order or give any

direction which appears ... to be appropriate for the fair and expeditious disposal

of the case and to do justice to the parties".

6. Having examined the context from which the present applications arise, the

undersigned Judges consider that judicial efficiency and justice will be better

served by having the same Judge adjudicating the above-mentioned cases.

7. Noting the present stage of proceedings in Case No. UNDT/GVA/2018/055,

the undersigned Judges agree that the remaining four cases in question be

reassigned to Judge Francesco Buffa who, in the regular course of case

management, will consider whether to join the cases and, if so, decide on the

modalities of a joinder.

IT IS ORDERED THAT:

8. The UNDT Geneva Registry take appropriate administrative action to

reassign to Judge Francesco Buffa Cases No. UNDT/GVA/2018/059

and 063 (Patkar) and Cases No. UNDT/GVA/2018/114 and 115 (Williams).
