At the time of the contested decision, the Applicant was a Chief 1.

Administrative Officer at the United Nations Mission in the Democratic Republic of

Congo (MONUC). The issue in this Application was whether compensation awarded

to the Applicant by the administration pursuant to a Joint Appeals Board

recommendation was adequate.

2. On 27 May 2010, the Parties were ordered to inform the Tribunal by 4 June

2010 of whether they were prepared to consider the option of mediation before

consideration and determination of the present case<sup>1</sup>. The Tribunal further ordered

that in the event that the Parties were not agreeable to exploring a mediated

settlement, they were to submit their respective responses to questions contained in

paragraph 5 of the said Order by 30 June 2010.

3. By a Motion dated 4 June 2010, the Respondent informed the Tribunal that

discussions were ongoing between the Parties in this matter and requested the

Tribunal to grant an extension of time until 30 July 2010 to allow the Parties

sufficient opportunity to pursue those discussions. The request was granted on 29

June 2010. On 5 August 2010, the Parties filed a joint statement in the following
