Introduction

1. The Applicant is a former Movement Control Assistant at the United Nations Mission in the Democratic Republic of Congo. On 10 March 2024, he filed an application contesting the 19 December 2023 decision to impose on him the disciplinary measure of separation from service with compensation *in lieu* of notice and without termination indemnity pursuant to staff rule 10.2(a)(viii), and to enter his name in the UN ClearCheck database.

- 2. On 18 September 2024, the Tribunal issued Order No. 127 (NBI/2024) setting this matter down for an oral hearing between 11 and 14 November 2024.
- 3. On 29 October 2024, the Department of Conference Services wrote to the Registry for access to the trial bundle to facilitate the interpreters' preparation for the hearing.

Considerations

- 4. As the parties were not directed to file a Trial Bundle in advance of the hearing in this case, the Tribunal has decided that *both parties* and the *specific interpreters assigned to this case* will have *temporary* access to the Registry's Case Binder.
- 5. Given the nature of this case, the Case Binder is being disclosed strictly under seal in that any sharing of the document therein or link to the document is expressly prohibited.

Conclusion

- 6. The Registry is hereby directed to provide the parties and the interpreters assigned to this case access to the Case Binder on **Monday 4 November 2024.**
- 7. The Tribunal cautions all those in receipt of the document to ensure that the information contained therein is handled with this utmost care and discretion.
- 8. Access to the link to the Binder and the documents therein is limited strictly to the named recipients of it.
