Introduction

1. On 21 May 2021, Counsel for the Applicants filed an application contesting the

"unilateral change in the individual workload standards for translation and self

revision" on behalf of 34 staff members of the Department of General Assembly and

Conference Management ("DGACM"). The case was registered with case number

UNDT/NY/2021/021.

2. On 7 June 2021, the Respondent filed a motion moving the Tribunal to

determine the receivability of the case as a preliminary matter and to suspend the

deadline for the filing of the reply.

3. On 7 June 2021, Counsel for the Applicants filed a second application

contesting the same alleged decision on behalf of another 68 staff members of

DGACM. This case was registered with case number UNDT/NY/2021/024.

4. On the same day, the Tribunal served this application on the Respondent

informing him that this case will be handled jointly with case no. UNDT/NY/2021/021.

5. Given that the Respondent challenges the receivability in case no.

UNDT/NY/2021/021 and as both cases will be handled jointly to ensure an efficient

case disposal, the Duty Judge has determined that it is appropriate to grant the

Respondent the opportunity to review the filings in UNDT/NY/2021/024 and confirm

whether he also wishes to make submissions on receivability in this case.

6. The Applicant will then be afforded the opportunity to respond to the

Respondent's submissions on receivability for the joined cases.

8. By 4:00 p.m. on Monday, 21 June 2021, the Respondent shall file any

submissions on receivability concerning case no. UNDT/NY/2021/024;

9. By 4:00 p.m. on Monday, 12 July 2021, the Applicant may file a response to

the Respondent's submissions on receivability jointly for cases nos.

UNDT/NY/2021/021 and UNDT/NY/2021/024;

10. As per usual practice, these joint cases will be assigned for adjudication to a

Judge of the Dispute Tribunal in due course who will make a determination on the

preliminary issue and provide any further instructions on case management as required;

and

11. The deadlines for the filings of the Respondent's replies in both cases are

hereby suspended until further instructions are provided by the Judge of the Dispute

Tribunal who will adjudicate the case.
