Introduction

1. By application filed on 26 April 2024, the Applicant, a former staff member

of the United Nations Development Programme ("UNDP"), contests the decision

dated 1 February 2024 to separate her from service with compensation in lieu of

notice and without termination indemnity.

2. On 28 May 2024, the Respondent filed a reply in which he contends that

the application has no merit.

3. Following the Tribunal's Order No. 086 (NY/2024) dated 23 July 2024 and

a subsequent extension of the deadline, the parties filed a joint submission of

consolidated lists of agreed and disputed facts on 30 August 2024. Each party also

filed their separate submissions on evidence on 30 August 2024, including the lists

of witnesses they intend to call if the Tribunal orders a hearing.

4. The case was assigned to the undersigned Judge on 23 December 2024.

**Considerations** 

5. Pursuant to art. 19 of the Rules of Procedure of the Dispute Tribunal, the

Tribunal may at any time issue any order or give any direction which appears to be

appropriate for the fair and expeditious disposal of a case and to do justice to the

parties.

6. Having considered the parties' submissions, the Tribunal has decided to

conduct a case management discussion ("CMD") in this case. The purpose of the

CMD shall be to identify, discuss and agree on the claims and issues in the case and

generally to deal with any other matter which may facilitate a fair and expeditious

disposal of the case and to do justice to the parties.

7. The topics to be addressed at the CMD will include:

a. The scope of the application;

b. The need for a hearing and possible dates;

- d. Other issues identified by the Tribunal.
