1. Objectives

• Promote awareness of resolution 1540 (2004) and its full implementation;

• Dialogue with States on status of their implementation of resolution 1540 (2004) and explore opportunities for assistance requests and offers, as appropriate.

2. Background

The BWC Meeting of Experts is part of a four-year program of inter-sessional meetings mandated by the 2006 Sixth BWC Review Conference, aimed at strengthening the implementation of the Convention and improving its effectiveness as a practical barrier against the development or use of biological weapons.

The 2006 BWC Review Conference established the Implementation Support Unit (ISU) to assist States' implementation of the BWC. The ISU has a clearinghouse function to facilitate assistance for States' implementation of the Convention; and its website offers tools for implementation. The ISU provides administrative support to inter-sessional meetings agreed by the Review Conference as well as for workshops on national implementation, universalization of the Convention, and support and assistance for reports on Confidence-Building Measures submitted to the Geneva office.

3. **Highlights**

The meeting focused on two main themes: (1) biosafety and biosecurity; and (2) oversight, education, awareness, and codes of conduct. Participants shared best practices and new methods for biosafety and biosecurity. The 1540 Committee expert made a presentation on requirements of resolution 1540 (2004) and emphasized the mutually enforcing implementation efforts between it and the BWC. For example, physical protection measures for dangerous pathogens and toxins in a laboratory or measures to secure their handling and transportation with regard to implementation of the BWC or other regulations, also can contribute to implementation of resolution 1540. The BWC confidence-building measures to report on

legislative developments to implement the BWC can also contribute to (additional) reporting for resolution 1540.

4. Bilateral consultations

The 1540 Committee expert conducted dialogues with participating States on their implementation of resolution 1540 (2004), including opportunities for submitting additional information, such as voluntary national action plans and possible areas of technical assistance.
