1. Background

• Resolution 1977 (2011) encourages the 1540 Committee, with the support of necessary relevant expertise, to actively engage in dialogue with States on the implementation of resolution 1540 (2004).

• On 5 October 2015, Mr. Kyaw Moe Tun, Deputy Director-General of the International Organizations and Economic Department of the Ministry of Foreign Affairs of Myanmar, via a Note Verbale from the Permanent Mission of Myanmar to the United Nations dated 9 October 2015, extended an invitation to the Chair of the Committee requesting representatives of the Committee and members of the 1540 Group of Experts to participate in the national round table to facilitate the event and relevant assistance to support the national implementation of resolution 1540 (2004).

2. **Highlights**

The workshop included more than 30 participants from all relevant ministries and agencies in the Government of Myanmar working in nuclear, chemical and biological areas and in the fields of export and border controls. The participants learned about different aspects of the resolution, especially effective tools used to monitor implementation such as national reporting, the 1540

matrix, visits to States at invitations and voluntary national implementation action plan. The matchmaking role of the Committee with regard to assistance was highlighted during the discussion. Myanmar demonstrated a strong commitment to disarmament, non-proliferation and support for the implementation of resolution 1540 (2004) by reaffirming its cooperation with the 1540 Committee to move in the direction of full and effective implementation in Myanmar.
