### 1. Objectives of Participation of 1540 expert:

 Discuss and assess the development and implementation of Serbia's voluntary 1540 NAPs.

• Exchange views on national non-proliferation efforts and share lessons learnt and identify the Serbian needs for assistance, in particular in connection to capacity building.

### 2. Background

• On 2 February 2015, the Permanent Representative of Serbia to the United Nations through the Chair, invited representatives of the Committee to participate in a meeting, alongside the Second Annual Meeting of the OSCE Points of Contact (PoC) on UNSCR 1540, on 26 May 2015 with the Working Group for the Implementation of the 1540 voluntary National Implementation Action Plan (NAP) of the Republic of Serbia.

• The Serbian NAP was adopted in April 2012 and was prepared in cooperation with the 1540 Committee and its experts, supported by the OSCE. A Working Group was established for the implementation of the 1540 voluntary NAP.

• Serbia submitted five reports to the 1540 Committee. The latest was submitted on 12 May 2014.

## 3. Assessment

In the meeting, the 1540 Committee expert gave a detailed overview of the full range of 1540 obligations and updated the participants on the current activities and work of the Committee and the Group of Experts. The expert also led a detailed discussion on Serbian's national implementation of resolution 1540 (2004) based on the recent update Serbian 1540 matrix. The Serbian side agreed to update the 1540 Committee on a regular basis on its measures for the implementation of resolution 1540 (2004) in a manner to contribute to the comprehensive review.

The meeting provided a valuable platform for the 1540 Committee expert to discuss and assess the development and implementation of Serbia's voluntary 1540 NAP. Views were exchanged on Serbian's national non-proliferation efforts and the State's needs, in particular in connection to 1540 implementation capacity building, were further identified.
