More than 10.000










Buenos Aires City Waste collection system was no longer effective.



In order to find a solution and adjust the collection service,


a special research was made to study the citizenship's behavior and the cartonero's activity.






Area studied: 40 blocks, Microcentro

#### Conclusion:

There is a strong correlation between improper waste disposal and the cartonero's activity.

The research explained why the cartoneros start working heavily at 19:00 pm.





#### Cartonero's activity

Different types of cartoneros:

Nomads













Selected critical area: 746 blocks, Micro and Macro Centro of Buenos Aires City.

Target: Cartonero's families and recycler's employees

Instalation of 1000 liter containers to discard non recyclable waste





Main questions to be answered:

- Would the free willing "cartoneros" accept to use 1000 liter containers to discard non recyclable waste in them?
- How could it be possible to place containers on the narrow and crowded streets of the Microcentro?









- The selected area was divided in 6 sectors, bearing in mind the amount of cartoneros.
- In each sector containers are placed and stored in at least two parking lots.
- From 19:00 pm to 01:00 am containers are placed on the fixed working spots of the cartoneros.











At 19:00 pm. containers are transported to the "cartoneros" fixed working spots by street cleaners.



Needed resources in each sector:



- Two Collection trucks
- Four Street cleaners
- One Supervisor





### International Solid Waste Association Development of the taylor made solution







At 1:00 am. containers are taken back to the parking lots by the street sweepers.



#### Results of the taylor made solution



The joint work of the twelve trucks used in the "Pre-Recolección" system allows more than 60 tons of waste which was previously loose on streets to be now efficiently collected in containers, thus improving Buenos Aires City's hygiene.













#### Results of the taylor made solution

Pre Recolección's achievements allowed Buenos Aires City to:

- Diminish the cardboard worker's negative impact on streets, making non recyclable waste to be directly disposed in containers.
- Reduce the effects of having containers in narrow streets by placing them only when they are used.
- Make carboard worker's activity a cleaner one.
