



- Technology changes (blockchain/distributed ledger, innovation, big data, artificial intelligence)








Challenges to the Trade Industry


Extent to Which the Lack of Harmonization of Compliance Requirements Between Jurisdictions Poses a Challenge to the Trade Finance Industry


Extent to Which Banks' Trade Finance Transaction Processes Are Digitized
