Explanatory Notes on the Forum's 4POW for 2017-2020

- The Forum will carry out its core functions on the basis of the UN Strategic Plan for Forests 2017-2030.
 The Forum's 4POWs will represent the Forum's contribution to implementing the Plan and set the agenda for each Forum session within the quadrennium.
- Each 4POW will identify thematic and operational priorities and the resources needed by the Forum to take forward priority actions.
- The 4POWs will reflect the linkage between odd-year and even-year sessions of the Forum. As a general rule:
 - Odd-year sessions will focus on implementation and technical advice, including the sciencepolicy interface, with inputs from CPF members and regional, subregional and nongovernmental partners.
 - Even-year sessions will focus on policy dialogue, development and decision-making, taking into account the discussions and proposals of the previous session.
 - Odd- and even-year Forum sessions for a given biennium will be thematically linked. Themes for each biennium will be identified by the Forum based on the Global Goals and targets contained in the UNSPF, taking into account the annual themes and SDGs under review by the High Level Political Forum on Sustainable Development (HLPF).
- UNFF12 and UNFF 14 will focus on technical advice, and UNFF 13 and UNFF 15 will focus on policy dialogue, development and decision making.
- Since UNFF 12 in 2017 is the first session of the Forum following adoption of ECOSOC Resolution 2015/33 and the UN Strategic Plan for Forests, the session is transitional in nature and may take decisions on matters called for in ECOSOC resolution 2015/33 as needed to facilitate the Forum's work.
