I. INTRODUCTION

- 1. Table 2 of the UN Forum on Forests (UNFF) Quadrennial Programme of Work 2017-2020 (4POW) sets the agenda for the 13th session of the Forum (UNFF13) which will meet 7-11 May 2018 in New York (see <u>Annex 1</u>). Under Item 3 of Table 2, the Forum will consider three matters related to the Global Forest Financing Facilitation Network (GFFFN):
 - Item 3.a: Progress on the activities and the operation of the GFFFN
 - Item 3.b: Guidelines for the operation of the GFFFN
 - Item 3.c: Measures to increase the effectiveness and efficiency of the GFFFN
- 2. This background paper focuses on Item 3.b. The paper reviews existing guidance on the GFFFN and, building on this foundation, proposes a set of elements for guidelines for the operation of the GFFFN.

II. BACKGROUND

A. Purpose and priorities of the GFFFN

- 3. In 2015, based on the recommendation of UNFF11 (May 2015, New York), the UN Economic and Social Council (ECOSOC) established the GFFFN under the auspices of the Forum, building on the "facilitative process" launched in 2009 (ECOSOC resolution 2015/33). Consistent with the UN Strategic Plan for Forests 2017-2030 (UNSPF), the GFFFN aims to contribute "to the scaling up of sustainable forest management by facilitating access for countries to resources to implement the UNSPF and to achieve its Global Forest Goals and targets". The UNFF reaffirmed this purpose at its 12th session in May 2017.
- 4. Paragraph 60 of the UNSPF sets out four priorities for the GFFFN which draw on guidance contained in paragraph 13 of ECOSOC resolution 2015/33 (see <u>Box 1</u>).

Box 1 - Priorities of the GFFFN as set out in the UNSPF

- Promote and assist Member States in designing national forest financing strategies to mobilize resources for sustainable forest management, including existing national initiatives, within the framework of national forest programmes or other appropriate national frameworks.
- 2. Assist countries in mobilizing, accessing and enhancing the effective use of existing financial resources from all sources for sustainable forest management, taking into account national policies and strategies.

- Serve as a clearing house and database on existing, new and emerging financing
 opportunities and as a tool for sharing lessons learned and best practices from successful
 projects, building on the Collaborative Partnership on Forests (CPF) online sourcebook for
 forest financing.
- 4. Serve to contribute to the achievement of the Global Forest Goals and targets set out in the UNSPF, as well as the priorities contained in the Forum's 4POWs.

B. Existing guidance on operation of the GFFFN

5. Current guidance on GFFFN operations can be found scattered throughout ECOSOC resolution 2015/33, the UNSPF and the UNFF12 resolution. This guidance is compiled below. For ease of understanding, the relevant operative paragraphs are organized by general topic areas:²

Management

- A core function of the UNFF Secretariat is to manage the GFFFN. (E/2015/33³ paras 17.a.iii⁴ and 17.b.ii)
- The capacity of the UNFF Secretariat will be enhanced to effectively and efficiently manage the GFFFN. (E/2015/33 para 13.e)

Guiding principles

- The GFFFN should carry out its priorities as set out in the UNSPF in a balanced, effective and transparent manner. (UNFF12 resolution)
- Special consideration should be given to the special needs and circumstances of Africa, the least developed countries, low-forest-cover countries, high-forest-cover countries, medium-forestcover low-deforestation countries and Small Island Developing States, as well as countries with economies in transition, in gaining access to funds. (UNSPF para 61, E/2015/33 para 13.d)

Collaboration/partnerships (CPF, GEF, GCF)

- The UNFF Secretariat will implement GFFFN activities in collaboration with relevant members of the CPF. (E/2015/33 para 17.b.ii)
- Collaboration with the CPF in implementing the activities of the GFFFN will be strengthened. (E/ 2015/33 para 13.f)
- The GFFFN should promote the design of national forest financing strategies to mobilize resources for SFM to facilitate access to existing and emerging financing mechanisms, including the Global Environment Facility (GEF) and Green Climate Fund (GCF), consistent with their mandates, in order to implement SFM. (E/2015/33 para 13.b)

- The UNFF secretariat should engage in discussions with the GEF secretariat to facilitate collaboration between the GEF and UNFF to support eligible countries in gaining access to funding for SFM. (E/2015/33 para 14.f)
- The GEF Council is invited to request the GEF secretariat to discuss with the UNFF secretariat
 arrangements to facilitate collaboration between the GEF and the UNFF to support eligible
 countries in gaining access to funding for SFM. (E/2015/33 para 14.e)
- The GEF is invited to designate a staff liaison to serve as a link between the UNFF and the GEF, in order facilitate access to funding for SFM. (E/2015/33 para 15.b)

UNFF Trust Fund

- The Forum's Trust Fund can be used to support activities of the GFFFN. (UNSPF para 62)
- Member States are encouraged to provide voluntary contributions to the Forum's Trust Fund. (UNSPF para 62, UNFF12 resolution)

Monitoring and evaluation

- The Forum will monitor and assess the work and performance of the GFFFN on a regular basis, including the availability of UNFF Trust Fund resources⁵. (UNSPF para 63, E/2015/33 para 6.f.iii)
- The Forum will review and advise on the availability of resources for SFM funding, including the GFFFN, and ensure that the operation of the GFFFN is consistent with guidelines to be approved by the Forum.⁶ (E/2015/33 para 6.f.iii-iv)

III. PROPOSED ELEMENTS FOR GUIDELINES FOR GFFFN OPERATIONS

6. <u>Annex 2</u> contains a proposal for the guidelines for operation of the GFFFN which is comprised of 12 elements (see <u>Box 2</u>). The 12 elements incorporate and build on the guidance set out in ECOSOC resolution 2015/33, the UNSPF and the UNFF12 resolution (see section II) and take into account experience gained in taking forward the "facilitative process" and initial implementation of the GFFFN. The proposed elements in Annex 2 are structured as stand-alone document that can be readily understood by those who are not UNFF "insiders".

7. The proposed elements aim to provide clear, substantive guidelines for the effective and efficient operation of the GFFFN (assuming adequate funds are available for its operation) and to

foster accountability and transparency which are widely recognized as basic principles of good financial management. While the GFFFN is not a programme/project funding organization and currently carries out activities at a very modest scale, it is important that it operate in a manner that is accountable to the Forum and transparent to Member States, partners and stakeholders. This can be done through regular reporting, including financial reporting, and communication on GFFFN activities (e.g. participating countries, sources and levels of funding, allocation of resources, accomplishments, lessons learned and steps taken to upscale successes), as well as periodic independent evaluations of GFFFN operations. These practices will promote GFFFN effectiveness; enhance the confidence of Member States, partners and stakeholders in the Network; and help attract donor interest.

9. Funding and resource mobilization

- Member States in a position to do so are encouraged to provide voluntary contributions on a regular basis to the UNFF Trust Fund to support the GFFFN. UNSPF para 62, UNFF12 resolution
- The Secretariat will:
 - Work closely with CPF members and other cooperating organizations, including international financing mechanisms, to identify opportunities to leverage co-financing and in-kind contributions. *UNSPF para 60, E/2015/33 para 13.f & 17.b.ii*
 - Actively explore opportunities for funding support from other sources, including UN technical assistance programs, the private sector and philanthropic organizations.
 - Seek the Forum's guidance as needed on measures to ensure adequate funding for effective GFFFN operations.

10. Reporting and Communication

The Secretariat will:

- Provide a comprehensive annual report, including a financial report, to the UNFF on GFFFN activities, accomplishment and lessons learned.
- As requested, provide donors with information on the use of their voluntary contributions to the UNFF Trust Fund earmarked for the GFFFN.
- Highlight the GFFFN on the UNFF website and post regular updates of GFFFN activities.
- Highlight the GFFFN in the communication and outreach strategy developed by the Forum.

11. Monitoring and Evaluation

- The Forum, during its odd-year sessions, will:
 - Monitor and assess the work and performance of the GFFFN, including reviewing and advising on the availability of UNFF Trust Fund resources (UNSPF para 63, E/2015/33 para 6.f.iii-iv)
 - Ensure that the operation of the GFFFN is consistent with these Guidelines. (E/2015/33 para 6.f.iii-iv)
- The Secretariat will arrange for an independent evaluation of the effectiveness of GFFFN operations every four years coinciding with end of the Forum's quadrennial program of work, beginning in 2020.

12. Review

The UNFF will review these Guidelines in 2024 in the context of the mid-term review of the International Arrangement on Forests and revise them as needed. UNSPF 65.a para, E/2015/33 para 41
