CONCEPT NOTE

Global WORKSHOP ON REPORTING ON PROGRESS TOWARDS GLOBAL FOREST GOALS AND TARGETS

OF THE UN STRATEGIC PLAN ON FORESTS 2030

22 to 24 March 2023, FAO headquarter, Rome - Italy (hybrid)

I. Introduction

1. Through ECOSOC resolution 2022/17,¹ Members of the Forum requested the United Nations Forum on Forests Secretariat (UNFFS) to amend the format for voluntary national reporting, conduct a pilot phase using the amended format (with participation of interested countries), and to report back on the progress made to the Forum at its eighteenth session in May 2023. The same resolution requested the UNFFS to organize, in consultation with Members of the Forum, and jointly with FAO and other relevant members of CPF, a global workshop on reporting on progress towards Global Forest Goals (GFGs) and targets, with a focus on indicators that still have issues with data availability and estimation methodologies.

II. Background

- 2. Since its inception, UNFF continuously invited Member States to submit voluntary national reports on progress made towards sustainable forest management (SFM). In particular, the Forum called for reports on the implementation of the UN Forest Instrument, and the UN Strategic Plan for Forests (UNSPF) and its GFGs. These reports serve as the main sources of information to assess progress in implementation of the UNSPF, and achievement of its GFGs. The first round of national reporting on the progress towards implementation of the Strategic Plan was conducted in 2019-2020. National reports from 52 countries were submitted to UNFF15. The information from national reports, combined with quantitative data from the FAO Global Forest Resources Assessment (FRA) 2020² provided basis for Global Forest Goals Report 2021.
- 3. The analysis of the submitted reports revealed several challenges, including issues related to assessment methodology, access to data, and data availability. Data for quantitative targets, such as targets 1.1, 1.2, 3.1 and 3.2,³ are widely available and measuring progress towards these targets is relatively easily. However, lack of standardized and comparable statistical data remains a challenge for several other targets, notably those under GFG 2 and 4. The absence of, or difficulty in obtaining information related to the socioeconomic benefits of forests, their role in poverty eradication and income generation, employment, and health and food security poses a major challenge to assess the progress towards GFG 2. As these forest-driven benefits often accrue in the informal sector, it is even harder to obtain and measure such benefits. There is also a lack of reliable data on forest funding (GFG 4) due to the difficulty in accessing to financial information, including funding from private sector, as well as the complexity and fragmentation of forest financing landscape, and financial flows.
- 4. In light of the above, and in response to the request from Members of the Forum, the UNFFS and FAO are jointly organizing this global workshop. In response to paragraph 22 of ECOSOC resolution 2022/17, the UNFF Secretariat is also conducting a pilot phase for the use of the refined format for voluntary national reporting with interested countries. The pilot phase is currently ongoing, and it will end in February 2023. The results of the pilot will be shared with participants at the Global Workshop.

III. Objectives

5. The workshop will focus on identifying possible sources for data collection, and methodologies for monitoring and reporting on the GFGs and their targets, which are difficult to monitor and report on, due to the lack of statistical information and data. During the workshop, the results of the pilot phase for the use of amended reporting format, including lessons-learned and feedback will be also shared. Participants will have the opportunity to share their knowledge and national experiences with the access to and availability of forest data. Furthermore, lessons-learned on selected GCS indicators will be shared related to the improvement of methodologies and approaches to further enhance data availability. The workshop will also provide an occasion for experts to provide: i) additional suggestions, proposals,

and modification to the amended reporting format, and ii) suggestions to advance the work on selected indictors of the Global Core Set of forest related indicators for reporting on progress towards the GFGs.

IV. Date, venue, format and the expected outcome

6. The workshop will be held from 22 to 24 March 2023 in a hybrid format, at FAO headquarters in Rome, Italy. This workshop includes an in-person and virtual components. The daily meetings will be held from 9.30 am to 12:30pm, and from 2:00pm to 5:00pm local, Rome time. Arrangements will be also made to allow participants who wish to do so, to join the meeting through virtual means. The draft programme of work for the workshop is contained in the annex to this concept note. The meeting will be conducted in English. The meeting will be co-chaired by two Co-Chairs to be elected by participating experts in the workshop.

V. Participants and Meeting Registration

7. The workshop participants consist of experts from countries and CPF member organizations, who work on forest inventory, forest related data collection and reporting, and have a good knowledge of forest related reporting requirements to UNFF and/or FAO. All participants are expected to be familiar with the GFGs and targets of the UNSPF and the reporting requirements of the UNFF. Relevant experts from Member States who were directly involved in preparing national reports to UNFF15 and/or are involved in the pilot phase for the use of the amended reporting format, are particularly welcome to join this workshop. The Members of the Forum should send their nominations to the UNFF Secretariat through an official letter via respective Permanent Missions in New York, by **3 February 2023.** CPF nominations should be sent directly to the Secretariat by the respective head of entity using the entity's official letterhead.
