#### 1. BACKGROUND

#### 1.1 Introduction to Forest Pavilion

The inaugural Forest Pavilion at the 2024 UN Climate Change Conference (COP29) will provide a central platform for all stakeholders to galvanize collective efforts in safeguarding and leveraging forests for a just, equitable, and sustainable future for all.

The main objectives of the Forest Pavilion are to raise the visibility of forests in climate COPs and their negotiations and provide a multi-stakeholder platform for advocacy and partnerships to showcase why forests matter in climate ambition and the sustainability of our planet by bringing together leaders in policy, law, science, and practice from around the world.

The summary report of the Forest Pavilion will be prepared as the outcome to provide key messages, highlights, and snapshots of the activities. The lessons of the inaugural Forest Pavilion at COP29 are expected to inform the design of the Forest Pavilion at the 2025 UN Climate Change Conference (COP30) in Brazil. The Forest Pavilion at COP29 will be organized by multi-stakeholder founding partners<sup>1</sup>. The Forest Pavilion will be established in the Blue Zone<sup>2</sup> as part of the reimagined SDG Pavilion organized by UN DESA.



#### 1. Background

- The Model Forest Act Initiative (MoFAI) is a groundbreaking initiative to develop a Model Forest Act as a systematic way to provide expertise, efficiency, and scale required to match the severity of the global forest crisis. The Model Forest Act is a legal blueprint for policymakers, legislators, and other stakeholders in designing a modern forest legal framework to meet 21st-century challenges such as climate change and biodiversity loss. It uses a systematic, interdisciplinary, multistakeholder, and evidence-informed approach to design a model legislative text that can be applied and tailored to country-specific contexts and needs.
- The MoFAI directly contributes to the Sustainable Development Goals (SDGs), including SDG 13's (Climate Action) goal to strengthen climate resilience and SDG 15's (Life on Land) goal to protect, restore, and promote sustainable use of terrestrial ecosystems. It also supports the Global Forest Goals and the Paris Agreement by providing a legal blueprint to assist countries develop policies that reduce deforestation, protect biodiversity, and mitigate climate change. The first part of this side event will provide an overview of the MoFAI's key features, benefits, development process, and opportunities for countries, especially developing countries.
- Alongside a strong legal framework, the judiciary plays a pivotal role in the
  implementation and enforcement of forest laws. The second part of this side event will
  highlight the judiciary's crucial function in upholding environmental laws and
  safeguarding forests. Judges from various regions will discuss challenges such as evolving
  laws, transnational deforestation, and enforcement difficulties. They will also share
  strategies to enhance judicial effectiveness, including robust legal frameworks and
  enforcement mechanisms.

#### 1. Background

- As climate change impacts become more evident, international cooperation is crucial for effective climate action. Forest ecosystems are vital for reducing greenhouse gas emissions and enhancing resilience. The UNFCCC Warsaw Framework for REDD+ and Articles 5 and 6 of the Paris Agreement provide essential policy frameworks to facilitate forest-based climate actions.
- The 2023 Nationally Determined Contributions under the Paris Agreement: Synthesis
  Report by the Secretariat indicates global GHG emissions could peak before 2030,
  potentially decreasing by 8.2% from 2019 levels. Achieving this depends on implementing
  NDC conditional elements, accessing financial resources, technology transfer, and
  fostering international collaboration to integrate climate objectives into national policies.

#### 2. Session Objectives

The session aims to strengthen international climate cooperation by showcasing the role of policy and legal frameworks in supporting forest-based climate actions. It will also highlight ongoing initiatives and share strategies to integrate climate objectives into national policies and leverage market mechanisms for sustainable forest management.
