Voluntary National Report on progress towards the implementation of the UN Strategic Plan for Forests 2017–2030, the UN Forest Instrument and Voluntary National Contributions

Thank you for taking the time to complete the voluntary national report to the UN Forum on Forests (UNFF).

Before you start, please take note of the following important information:

- 1. The Economic and Social Council, in its resolution 2022/17, requested the UNFF secretariat to amend the format for voluntary national reporting to the Forum, taking into account the suggestions and proposals received from members of the Forum, and conduct a pilot phase for the use of the refined format. In the same resolution, the Council invited the Forum to consider establishing an advisory group on reporting. It further requested that the secretariat explore options for establishing an online reporting platform for the Forum, recognizing the need for streamlined reporting and minimizing the reporting burden, including the challenges faced by developing countries.
- 2. In fulfilling this mandate, the UNFF Secretariat has amended the format, taking into account the suggestions and proposals received from Members of the Forum and in consultation with the advisory group on reporting. The secretariat has also established an online reporting platform for the submission of voluntary national reports to the Forum.
- 3. The amended format is structured around the Global Forest Goals and targets of the UN Strategic Plan for Forests 2017–2030 (UNSPF) and builds on the previous format that was used for reporting to the UNFF15.

Since 2021, the country has received US\$6.4 million from the Forest Carbon Partnership Facility (FCPF) for the first 1.28 million tonnes of CO₂ reductions achieved in nine districts in Zambézia Province. The agreement provides for up to US\$50 million per 10MtCO₂ avoided by 2024.

Since 2021, partnership with Blue Forest (UAE) and Istituto Oikos to restore mangroves in the Zambezi Delta and coastal regions. Includes mapping, planting and development of PDD to access climate finance (including blue REDD+). Local communities lead planting.

Approximately 6,000ha have already been restored, surpassing the national target of 5,000ha; the MozBlue project aims to expand to 155,000ha and 200 million seedlings, with a marine carbon laboratory under development.

Launched in March 2021, funded by AFD (€6M), in partnership with BIOFUND, WWF and the Red Cross, the project protects and restores 15,000ha of mangroves, restores 390ha and creates community flood response plans and an emergency fund for protected areas.

Global Forest Goal 1 Challenges

9. What are the main challenges in achieving Goal 1 in your country? Please limit your answer to 250 words.

Mozambique faces several interconnected challenges to achieving Target 1, which aims to reverse forest loss, promote sustainable forest management and enhance forest-related benefits.

Deforestation remains high, mainly due to shifting cultivation, high demand for firewood and charcoal, and unregulated logging. Annual forest loss is estimated at over 267.000 hectares, mainly in the Miombo ecosystem.

Weak institutional capacity, combined with limited financial and technical resources, hampers the effective implementation of forest policies. Illegal logging, especially in remote areas, continues to exceed legal limits, undermining sustainability efforts.

Although community forest management mechanisms exist, benefit-sharing systems are often unclear or poorly implemented, reducing communities' motivation to conserve and restore forests. The country is highly vulnerable to cyclones, droughts and floods, which contribute to forest degradation and weaken the resilience of ecosystems and local populations. The lack of up-to-date forest inventories and limited remote monitoring tools hinder evidence-based decision-making. The expansion of infrastructure, mining and agriculture challenges conservation efforts, leading to forest conversion and fragmentation.

Implemented from 2021 under the MozFIP, this program launched in partnership with the World Bank and FNDS supports small investors, cooperatives, women and youth in the creation of multifunctional plantations and agroforestry practices. It includes ecological restoration and job creation.

In 18 months, 1858 ha of plantations established, 618 ha of degraded lands recovered and 2014 local jobs created (30% occupied by women)

Dedicated Grant Mechanism (DGM) - forest communities

Brief description of the action:

MozDGM, part of the Dedicated Grant Mechanism for Indigenous Peoples and Local Communities linked to the Forest Investment Program (FIP), has funded community-led subprojects in Zambézia and Cabo Delgado. Since 2018, it has strengthened community-based organizations (CBOs), promoted capacity building and forest-based entrepreneurship.

Main results achieved for the action:

According to the 2022 report, 786 people (49% women) received training; nine of the ten subprojects are led by women; average implementation progress was \sim 35% and disbursements \sim 46%

Defines the participation of local communities in revenues from the exploitation of forest and wildlife resources, establishing that 20% of revenues must be transferred to the local communities.

Forest restoration with agroforestry integration in Chimanimani

Brief description of the action:

Since 2021, the project led by the NGO Eden in Chimanimani has promoted the ecological restoration of more than 200,000 hectares of landscape with a focus on food security. The action includes agroforestry systems that combine native trees, fruit trees and subsistence food crops, strengthening food resilience and local ecosystems.

Main results achieved for the action:

More than 7,500 hectares restored and 1.5 million trees planted. Family farmers began to produce food in diversified forest systems, with improved nutrition and crop yields. It is estimated that the project can capture around 31 million tons of CO₂ equivalent.

Agroforestry systems with food crops within the scope of PFGS (MozFIP)

Brief description of the action:

The Planted Forest Grant Scheme promoted, in addition to forest restoration, the integration of agricultural crops between rows of trees (intercropping), such as corn, cassava, beans and sweet potatoes, in small-scale plantations.

Main results achieved for the action:

Increased food security for hundreds of family farmers, with income during forest growth. 1,858 ha of plantations established and 618 ha of degraded land restored.

Several initiatives, as part of the DGM program and the "Floresta em Pé" project, have promoted beekeeping in Miombo communities. Technical training, provision of hives and marketing of honey have stimulated sustainable economic activities linked to the forest ecosystem.

Income diversification, reduced dependence on charcoal and increased value of the standing forest. Participating communities report increases of up to 50% in annual income.

Brief description of the action:

Companies such as Portucel Moçambique have adopted FSC-certified management plans for eucalyptus plantations. The timber produced supplies local industries and is exported with added value, promoting legal and sustainable practices.

Over 56,000 ha of certified plantations; 30% increase in the export of legal timber from Zambézia. Job creation, technical training and socio-environmental benefits associated with the industrial forestry chain.
