## Voluntary National Report on progress towards the implementation of the UN Strategic Plan for Forests 2017–2030, the UN Forest Instrument and Voluntary National Contributions

Thank you for taking the time to complete the voluntary national report to the UN Forum on Forests (UNFF).

The Economic and Social Council, in its resolution 2022/17, requested the UNFF secretariat to amend the format for voluntary national reporting to the Forum, taking into account the suggestions and proposals received from members of the Forum, and conduct a pilot phase for the use of the refined format. In the same resolution, the Council invited the Forum to consider establishing an advisory group on reporting. It further requested that the secretariat explore options for establishing an online reporting platform for the Forum, recognizing the need for streamlined reporting and minimizing the reporting burden, including the challenges faced by developing countries.
- 2. In fulfilling this mandate, the UNFF Secretariat has amended the format, taking into account the suggestions and proposals received from Members of the Forum and in consultation with the advisory group on reporting. The secretariat has also established an online reporting platform for the submission of voluntary national reports to the Forum.
- 3. The amended format is structured around the Global Forest Goals and targets of the UN Strategic Plan for Forests 2017–2030 (UNSPF) and builds on the previous format that was used for reporting to the UNFF15.

# Action (short title): Forest Protection and Conservation Brief description of the action: Namibia actively protects and conserves its forests through a combination of state-led initiatives and community-based approaches. These include establishing protected areas, promoting sustainable forestry practices within community forests, and empowering local communities to manage and benefit from forest resources. Main results achieved for the action: 1. Forest and veld fire management: On average total of 1000 km of firebreaks have been constructed and maintained annually. Establishment of forest and veld firefighting units and training in basic fire suppression techniques have been carried out every year in various regions, especially in communal and communities' forest areas. The initiatives have influenced the reduction in forest and veld fire every year. 2. Law enforcement: Law enforcement activities such as patrol, roadblock, site inspection for harvesting forest resources and issuing of fines

Created awareness to the public on the Forest legislation, emphasizing conservation, forest fire management, forestry permits, illegal logging, and poaching of succulents. The awareness campaigns were conducted through local radio stations, community meetings, trade fairs, and agricultural and industrial shows. Through this initiative, compliance with Forest Policies and Legislations have improved.

#### Action (short title):

Community based Natural Resources Management

#### Brief description of the action:

Community based natural resource management (CBNRM) creates an environment where people in communal areas can actively manage their ecosystems. Where rights are given to the local communities to manage their natural resources. As a results, legally recognized community conservation organisations such as conservancies and community forests were formalized under the Nature Conservation Amendment Act of 1996 and Forest Act of 2001.

#### Main results achieved for the action:

1.Community Forest Establishment:

To date, a total of 47 community forest covering 9.7 million hectares has been established. The intervention focuses on activities carried out in collaboration with rural communities and organisations on communal lands focusing on devolution of, and sustainable management and utilisation of forest resources in those classified forests.

2. Establishment of State Forest

State forests are owned and managed by the government, they are established to protect forest resources of national importance, preserve ecosystems, and conserve biodiversity. There are 3 state forest gazetted in Namibia.

1. Illegal Logging and Unsustainable Harvesting:

Expanding populations and commercial exploitation of valuable timber species like Zambezi Teak and Kiaat are leading to deforestation and degradation.

2. Land Clearing for Agriculture:

Increasing demand for agricultural land, driven by population growth, results in the clearing of forest areas.

3. Uncontrolled Fires:

Frequent, uncontrolled fires, particularly in the late dry season, can be extremely damaging, affecting large trees and impacting forest ecosystems.

4. Climate Change:

Namibia's forests, like those globally, are vulnerable to the effects of climate change, including shifting temperatures, increased drought frequency, and more intense and frequent wildfires.

5. Lack of Awareness:

Lack of awareness about the existence and importance of forests in Namibia, even among some residents, politicians, ecologists, and general public. This can hinder conservation efforts.

This is not always visible as logging, but the unsustainable harvesting of resources like devil's claw, used in traditional medicine, can also pose a threat.

Value addition to forest resources primarily involves processing raw timber and non-timber forest products into higher-value items, creating economic opportunities for communities and reducing reliance on exporting raw materials.

#### Main results achieved for the action:

1. Woodworking:

Transforming raw timber into furniture, construction materials, and other finished wood products.

2. Charcoal Production:

Converting wood into charcoal, a valuable fuel source, and potentially using byproducts like biochar for soil improvement.

Community forests in Namibia can access grants through various channels. These grants support community-based natural resource management (CBNRM) initiatives, such as the alternative income-generating projects, human-wildlife conflict mitigation, and critical support services for community forests.

#### Main results achieved for the action:

Grant Opportunities and Support:

1. Community Conservation Fund of Namibia (CCFN):

CCFN provides grants for investment in alternative income-generating activities in conservancies and community forests, particularly those affected by the COVID-19 pandemic.

2. Environmental Investment Fund of Namibia (EIF):

EIF offers grants through its Small Grants Facility, with funding windows for Restoration and Climate Proofing, and Eco-Enterprise Adaptation.

3. Namibian Association of CBNRM Support Organisations (NACSO):

NACSO provides technical expertise and support through its working groups (Natural Resources, Institutional Development, and Business, Enterprises & Livelihoods).

4. Directorate of Forestry:

The Directorate of Forestry within the Ministry of Environment, Forestry and Tourism (MEFT) provides support to community forests management and administration.

5. Other Partners:

Non-governmental organizations (NGOs) are recognized as key partners in supporting CBNRM processes, including linking communities to funding sources.

Key Areas for Grant Funding received:

1. Alternative income-generating activities:

Developing businesses based on sustainable natural resource use, such as eco-tourism, craft production, or harvesting of non-timber forest products and horticulture.

2. Human-wildlife conflict mitigation:

Implementing measures to reduce conflict between humans and wildlife, such as fencing, livestock guarding, and early warning systems.

3. Critical Support Services:

Funding for core CBNRM activities, including natural resource management, governance, financial management, and capacity building.

5. Restoration and Climate Proofing:

Projects focused on restoring degraded ecosystems through tree planting at local level and building resilience to climate change impacts.

#### Action (short title):

Forests and trees play a vital role in food security

#### Brief description of the action:

Forestry resources significantly contribute to food security through various interventions by the Directorate of Forestry through the Ministry of Environment, Forestry and Tourism and support partners.

#### Main results achieved for the action:

1. Tree planting and Orchard development

Fruits tree seedlings are being produced in government nurseries country wide and sold at subsidized price to increase off-take by the public for planting. The directorate supported and established community orchards in various regions as demonstration plots to promote food production through orchard development.

2. Bee keeping

Beekeeping in Namibia offers great potential, especially given the country's unique climate, diverse flora, and increasing interest in sustainable agriculture and income diversification. Farmers and community forest were trained on bee keeping management and techniques, and this have increased the farmer and honey production

3 Forest conservation and protection activities implemented have increased the direct and indirect food production forest resources such as:

Direct food provision

#### Edible Products:

Forests and trees provide a range of edible products, including fruits (like marula), nuts, seeds, leaves, roots, and bushmeat.

Insects:

Some forest insects, like mopane worms, are a significant source of protein and income.

Livestock Fodder:

Trees and shrubs provide fodder for livestock, supporting meat and milk production.

Indirect food provision

#### Soil Fertility:

Trees like Acacia erioloba, G. coleosperma, and F. albida improve soil fertility through nitrogen fixation and nutrient cycling.

Water Conservation:

Forests help regulate water cycles, improving water availability for both humans and agriculture. They also reduce soil erosion, preventing land degradation and maintaining fertile topsoil.

#### Brief description of the action:

Namibia is a Namibia is a signatory to the Rio Convention on Biological Diversity (CBD) and recognizes the interconnectedness of biodiversity conservation and climate change, integrating both into its national policies and strategies. The country's approach emphasizes adaptation, mitigation, and the crucial role of reduction of carbon emission and increases carbon storage.

#### Main results achieved for the action:

1. National Implementation:

Namibia has demonstrated a commitment to the CBD by establishing a national biodiversity policy in 1994 and a National Biodiversity Programme. The policy focuses on the conservation of biological diversity, the sustainable use of its components, and the fair and equitable sharing of benefits from genetic resources.
