Concept Note

I. Background

The "Building for Forests: Accelerating Responsible Wood-Based Constructions for Climate, Forests and Livelihoods" Plan — part of the COP30 Action Agenda — will be launched on 18 November. It presents an impactful solution that extends the climate benefits of forests to the built environment and to sustainable, affordable housing.

Format

The session will follow a fishbowl discussion format designed to promote open and inclusive dialogue. A small group of participants sits in an inner circle to exchange views, while the wider audience forms an outer circle to observe and listen.

In this moderated "shoulder-tap" variation, audience members may indicate their wish to join the inner circle — either by a gentle tap on the shoulder of an inner participant or by a non-contact signal. The tapped participant then leaves the inner circle temporarily, allowing the new participant to take their place and contribute to the discussion. Participants who have been tapped out may re-enter the fishbowl later in the session, ensuring that a wide range of voices and perspectives can be heard.

II. Objectives

- Surface cross-stakeholder expectations of forest-positive buildings outcomes and impacts (climate, biodiversity, livelihoods, rights, risk reduction).
- Identify near-term SFM priorities to strengthen first (e.g., conversion-free management, lesser-known timber species, mixed-species plantations, biodiversity/habitat quality, safe and decent work, inclusive smallholder pathways, fire/water resilience, impact/outcome data, integrity & assurance).

• Suggest a short list of decision-useful actions that need to be delivered in the short term (24-36 month) to achieve a fundamental shifts in paradigm, technology, finance and policy.

Round 1 (20 minutes)

Wood-based constructions deliver climate benefits, carbon-neutral and resilient built environment, and sustainable affordable housing. It's a forest-based climate solution intrinsically cross-sectoral.

Guiding questions:

- How can we ensure the uptake of the solution globally to meet the proposed targets?
- What actions to adopt in forest Global South countries?

Round 2 (20 minutes)

Building for forests depends on innovation, policy coherence and finance. The wood-based constructions sector is already under development, but to meet the urgency and make it work for forests and livelihoods demand deviation from business-as-usual.

Guiding questions:

- How can we expand innovation networks to adapt technologies to local contexts?
- What partnerships between public and private sectors are needed to make sustainable wood part of mainstream construction finance and real estate portfolios?
