Concept Note

I. Background

The session "From Investment to Impact: The Role of the Private Sector in Restoring Priority Territories" will explore how Brazil is building an enabling environment for large-scale restoration through the connection between public policy, territorial intelligence, and private capital.

Led by the Ministry of the Environment and Climate Change (MMA) and the Igarapé Institute, the session will present the national methodology for identifying priority territories for restoration, which integrates environmental, social, economic, and market variables to guide investment decisions. This approach seeks to ensure that restoration actions generate high-impact, measurable, and long-term results.

By engaging government, private sector, and civil society partners, the session will demonstrate how national policies — such as the PLANAVEG — and emerging financial platforms — such as the Brazil Investment Platform (BIP) and the Brazil Restoration and Bioeconomy Finance Coalition (BRB) — can align to make restoration a central pillar of Brazil's green and inclusive economy.

II. Objectives

• Present the national methodology for defining priority restoration territories developed by SBio/MMA and ASECON/MMA.

- Discuss the role of the private sector in consolidating a restoration economy, emphasizing innovative financial instruments and public-private partnerships.
- Explore synergies between public policies, investment platforms, and corporate commitments to strengthen a high-impact, high-integrity restoration ecosystem.
