Concept Note

I. Background

The Amazon Cooperation Treaty Organization (ACTO), composed of its eight Member Countries (Bolivia, Brazil, Colombia, Ecuador, Guyana, Peru, Suriname, and Venezuela) is the official intergovernmental mechanism for cooperation and political and technical dialogue in the Amazon Region. Through coordinated joint actions, the Permanent Secretariat of ACTO promotes sustainable development and equitable, shared benefits among ACTO's Member Countries, as established in the Amazon Cooperation Treaty.

Within this framework, ACTO has developed the Regional Amazon Forest Program, primarily focused on sustainable forest management. Following a mandate from the Presidents of the eight countries, its implementation was further strengthened through the creation of the Amazon Network of Forest Authorities (RAFO), a regional mechanism that coordinates forest-related policies and actions across the Amazon Region.

The RAFO plays an important role in advancing sustainable forest management on the Amazon and it is of outmost importance for reducing deforestation and forest degradation, aligning its objectives with the global commitments reaffirmed under COP30 and the United Nations Forum on Forests (UNFF). Its coordinated approach enhances coordination of policies and actions, fosters knowledge exchange, and strengthens collective actions to safeguard Amazonian forests which are essential worldwide.

RAFO currently has an approved Work Plan that outlines a series of priority activities for the coming years. In this context, and as part of the initial steps toward implementing these activities, RAFO aims to organize a session with its members to share successful experiences in sustainable

forest management and to identify the challenges and opportunities for replicating these practices at the regional level.

- 1. Promote dialogue and cooperation fostering the exchange of successful experiences and best practices in sustainable forest management in the eight ACTO Member Countries supported by the Amazon Network of Forest Authorities (RAFO).

- 2. Compilation and dissemination of successful national experiences that can inform RAFO's Work Plan and promote replication across the Amazon Region.
- 3. Common understating regional challenges and opportunities to implement effective strategies for reducing deforestation and forest degradation.
- 4. Reinforced alignment of regional forest governance actions with the goals and commitments of COP 30 and the UNFF.
- 5. Next steps identified through a roadmap of coordinated regional initiatives and partnerships to support RAFO's implementation and long-term sustainability.
