Why MGs at the UN?

- Increase legitimacy of UN political processes
 - Transparency
 - Participation
 - Empowerment
- Bridge the gap between political negotiations and stakeholder groups
- Achieve broader societal awareness of UN political discourse

Achievements & Contributions of MGs

- Extended platform for stakeholder consultations
- Participated in all UNFF Sessions & many countryled initiatives
- Organized Major Group-led Initiatives
- Established public speech time at MSD
- Contributed background papers & joint position papers, uniting diverse groups
- Founding of MGPoF

Weaknesses

Limitations in civil society participation in the IAF

Low Institutional Priority

- Little institutionalized MG engagement
 - Insufficient staff at UNFF to
 - Facilitate/Leverage MG inputs in UNFF processes
 - Monitor MG activities on the ground
 - No mechanisms to foster and monitor implementation of civil society recommendations
 - No mechanisms to engage broad MG networks in contributing to monitoring of country commitments

Little Political Relevance

- During UNFF Sessions plenary presentation only at 3hr MSD
 - Little opportunity for feedback from negotiators
- Little direct interactions with policy makers
- Joint policy papers & recommendations not reflected in political agenda
- Fragmentation: little cross-sectoral exchange

Low Financial Resources

- Erratic support for MG intersessional activities & biennial sessions
 - Intersessional activities rely on ad hoc funding
 - Session participation only financed for the first week

Recommendations

Suggestions that may help overcome the mentioned shortfalls

Structural Recommendations

- Strengthen the UNFF Secretariat
 - Regional liaison positions to facilitate & monitor implementation
 - Establish an MRV platform for implementation
- Institutionalize cross-sectoral alliances
 - Exchange with UNCBD, UNFCCC, UNCCD, UNCSD
- Engage MGs at all political levels
 - Establish MG consultation in national & regional processes

Recommendations to Finance MGs

- Allocate targeted resources to enable & leverage MG activities
 - Fund for MG outreach & advocacy initiatives
 - Institutional funding to MGPoF
- Build partnerships to "outsource" costs while increasing scope and competence
- Build a strategic funding network

Recommendations during UNFF Sessions

- Reinstitute practice of MG meetings with Bureau each morning
- Include/Invite MGs to briefings of UN bodies
- Urge Member States to invite MGs for consultations
- Facilitate MG meetings with IGOs and other relevant actors

Recommendations for Intersessional Activities

- Support MGPoF
 - Help establish & promote website
 - Promote MGPoF across UN bodies and beyond
- Promote & support MGs for awareness raising activities
 - E.g. for the International Day of Forests
- Require MG reporting of the status of their constituencies

Recommendations for MG focal points

- Establish transparent means of communication with constituencies
 - Appraise and increase awareness
 - Report back feedback to UN & relevant entities
 - Incorporate range of opinions in MG statements
- Acquire new organizational partners
 - Access to information & knowledge sharing
 - Channels/networks to foster policy distribution
 - Technical, financial, political support
- Reactivate and encourage MG focal point contributions

Recommendations for MG focal points cont'd

- Develop strategy for forests' representation in SDGs
 & post-2015 development agenda
 - Strategic networks with other natural resource organizations
