# I. KEEPING THE PROMISE

## A. The significance of the September Summit (overall messages)

- (a) The importance of MDG's in the broader development agenda
- (b) The MDGs are achievable with the right policies, strengthened institutions, adequate resources, investment and strong international partnerships.
- (c) The need to meet commitments, rally support and spur collective action
- (d) The need to recognize the interconnectedness of MDGs
- (e) The need to concentrate on the implementation of a clear and targeted action agenda for the poor with a special focus on the most vulnerable people and countries
- (f) Recommitment to the values and principles of the Millennium Declaration and World Summit Outcome
- (g) The need for a country-specific approach building on successful approaches and lessons learned
- (h) The need for robust monitoring of progress and enhancing accountability

# II. THE WAY FORWARD – AN ACTION AGENDA FOR THE POOR

### A.Key elements of concrete strategies:

(a) Policies:

- Strengthening national ownership and leadership
- Empowering women, including by promoting gender sensitive approaches;
- Promoting sustained and inclusive economic growth
- Working towards universal access to social services and social protection and reduce inequalities

(b) Institutions:

- Strengthening the capacity of national institutions, incl. through community-based and participatory approaches
- Strengthening international and regional institutions for cooperation

(c) Financial resources:

- Mobilizing domestic resources
- Mobilizing international resources
- Mobilizing additional and innovative sources of financing
- Better monitoring and data to promote enhanced accountability of all stakeholders

# **B.** Targeted Actions for the Achievement of the MDG's by 2015

The way forward summarizes the "action agenda for the poor" by stressing how the lessons learned, approaches, the renewal for commitments and the strains in the achievement (brought about by the new and emerging crises) will help define the new agenda. It should capture the optimistic expectation that MDG's can be achieved. The action agenda should help guard past gains and insulate them from crisis induced reversals, by aiming for sustained and equitable growth that maximizes poverty reduction and progress on all MDGs.
