Add the following paragraphs at the end of the text

135 (d) **Assess the extent to which poverty eradication programmes have a positive impact on the empowerment of women living in poverty in terms of access to training and education, employment, inheritance skills and social services, as well as access to and control over land, income and credit, and define concrete changes in such programmes in the light of the above assessment;**

135 (e) *Establish social development funds to minimize the negative effects of structural adjustment programmes and trade liberalization on women and the disproportionate burden borne by poor women;*

**Recognizing that gender equality is a prerequisite for poverty eradication, elaborate and implement, in consultation with civil society, gender-sensitive poverty reduction strategies addressing social,**

**structural and macroeconomic issues in a coherent and mutually reinforcing manner in order to mitigate possible adverse effects of structural adjustment programmes and trade liberalization policies [as well as to reduce the social costs of the transition process];**
