CONSULTANTS

Mary E. Daly (United Kingdom) is a professor at the School of Sociology, Social Policy and Social Work at Queen's University in Belfast. She has a PhD from the European University Institute in Florence. She has wide-ranging scholarly interests in comparative European social policy, especially the changing nature of the welfare state as it impacts upon gender, poverty, family and labour market. Her publications have been on these topics, especially gender from a comparative welfare state perspective, and she has been looking at family policy and developing her thinking on 'care'. She is a member of a number of European research networks on the changing nature of social policy and regularly carries out work on this and other topics in an international context for the European Commission, the Council of Europe and the ILO, inter alia. Her recent books include: *The Gender Division of Welfare*, Cambridge University Press (2000), *Care Work: The Quest for Security*, ILO (2001) and *Gender and the Welfare State: Care, Work and Welfare in Europe and the US*, (with K. Rake), Polity Press, (2000).

Elissa Braunstein (USA) is an Assistant Professor, Department of Economics, Colorado State University, Fort Collins. She has a PhD in economics from the University of Massachusetts, Amherst. She served as the Moderator for the DAW online discussion on "The equal sharing of responsibilities between women and men, including care-giving in the context of HIV/AIDS". Her research specializes in gender, macroeconomics and the economics of the household, with particular emphasis on how globalization and industrialization affect women's market and non-market work in East Asia. Her publications include, among others, 'Women's work, autonomy and reproductive health: the role of trade and investment liberalization' in C. Grown, E. Braunstein and A. Malhotra (eds) *Trading Women's Health & Rights? Trade Liberalization and Reproductive Health in Developing Countries* (2006).

EXPERTS

Olagoke Akintola (Nigeria) is a public health promotion specialist and senior lecturer at the School of Psychology, University of KwaZulu-Natal, South Africa. He received a PhD in Gender and Health from the University of Natal. His research interests are in the gendered dimensions of informal/home-based care for people living with HIV/AIDS, and the socio-economic impact of HIV/AIDS on communities, households/families and the private/public sector. Presently, he is conducting research on the gendered ramifications of health and development as well as other policies on the health and socio-economic wellbeing of families and communities. His publications include, among others, 'Gendered home-based care: more trouble for the troubled' *African Journal of AIDS Research* 5(3) (2006).

Valeria Esquivel (Argentina) is a Researcher and Assistant Professor of Economics at Universidad Nacional de General Sarmiento. She is a PhD candidate at the University of London. Among her research interests is economic and social policy from a gender perspective. She has designed and coordinated the collection of the Buenos Aires Time Use Survey 2005. Based on that data, she has done work on how income inequalities exacerbate inequalities in the distribution of paid and unpaid care work between women and men and across social class. Her

publications include, among others, 'Explorations: Time-use surveys in the South' (with D. Budlender, N. Folbre and I. Hirway) *Feminist Economics* (July 2008).

Susan Himmelweit (United Kingdom) is professor of economics at Open University. She has a PhD in economics from Cambridge University. She is interested in various aspects of the economics of caring, including the macroeconomics of caring, caring as a distinctive relational labour process and explanations of caring behaviour at the micro-level. She is presently engaged in a research project entitled *Within household inequalities and public policy* which examines the impact of policy changes on behaviour and distribution within households. Her publications include, among others, 'The Prospects for caring: economic theory and policy analysis' in *Cambridge Journal of Economics* 31(4), 2007.

Indira Hirway (India) is the director of the Center for Development Alternatives, Ahmedabad, India and a professor of Economics. She has a PhD in economics from the University of Bombay. The areas of her research interests include poverty and human development, labour and employment, gender development, environment and development, environmental accounting and time use studies. She has worked as a consultant at UNESCAP and UNIFEM. She has written and edited several books and articles, including *Application of Time Use Statistics* (editor for CSO, Government of India and UNIFEM, 2003).

Masako Ishii-Kuntz (Japan) is Professor at the Department of Social Sciences and Family Studies at Ochanomizu University in Japan. She has a PhD in sociology from the Washington State University. Her areas of research include the gender dynamics in families, including sharing of domestic labour, parenting, and fatherhood. Currently, she is examining how fathers are involved in child care and housework in order to better understand work and life balance issues in Japanese families. Her publications include, among others, 'Child Caring Fathers in Japan and the USA' *Annual Report of the Institute for International Studies* (2006).

Linden Lewis (Guyana/ Barbados) is Chair of the Department of Sociology and Anthropology at Bucknell University, and the vice-president of the Caribbean Studies Association. He has a PhD in sociology from the American University in Washington DC. He specializes in analyzing gender-based work relations, and has published on the topic. He has written numerous articles in various media that focus on masculine identities. He is the co-editor of *Color, Hair, and Bone: Race in the Twenty-First Century* (2008). Mr. Lewis has previously worked with DESW/ DAW in its expert group meeting on the Role of Men and Boys in Achieving Gender Equality.

Esther Mwaura-Muiru (Kenya) is national coordinator of GROOTS, Kenya. She has a BA (Hons) and several post-graduate courses from the University of Nairobi. The mission of her organization is to promote the direct participation of poor people, and particularly women, in the development process, and has major investment in partnership with grassroots women leaders focusing on gender local governance and HIV/AIDS. She has a special interest in gender analysis, governance and HIV/ AIDS work. She is a board member of a number of international organizations.

Dean Peacock (South Africa) is the South Africa Programme Manager and South and East Africa Men as Partners Technical Advisor for EngenderHealth. He has a Master's degree in

social work from San Francisco State University. For the last 11 years Mr. Peacock has worked in South Africa, the United States and Latin America to end men's violence and to promote egalitarian, non-abusive models of masculinity that improve the lives of men, women and children and contribute to a more just society. His publications include, among others, 'Sonke Gender Justice and the "One Man Can" campaign' in *Financing Gender Equality: Commonwealth Perspectives* (2007). He has worked with DESA/ DAW in its expert group meeting on the Role of Men and Boys in Achieving Gender Equality.

Tine Rostgaard (Denmark) works as a senior researcher at the Danish National Centre for Social Research. She holds a PhD in comparative social policy from the Southern Danish University, Odense.
